Dear Shareholders,

On behalf of the Board of Directors (the "Board") of Cybernaut International Holdings Company Limited ("Cybernaut" or the "Company", together with its subsidiaries, collectively as the "Group"), I am pleased to present the annual report of the Group for the year ended 31 December 2022.

In recent years the International Monetary Fund (IMF) have seen unprecedented levels of global interest in Central Bank Digital Currencies (CBDCs). And the recent surveys have provided insights into the widespread exploration of CBDCs and the reasoning behind it. In regard to the April publicated policy paper by the IMF on its Approach to Central Bank Digital Currency Capacity Development this year, the global central banking community is found actively exploring CBDCs, which may have a fundamental impact on both the domestic and international economic and financial stability. Over 40 countries in the world have approached the IMF to request assistance through CBDC capacity development (CD); and the current IMF CBDC CD efforts have focused on facilitating the peer learning and developing analytical underpinnings for staff advice to the member countries. The CD missions have aimed at helping country authorities answer questions about how to think about CBDCs. With more available country experiments and empirical evidence, IMF CD will evolve to provide increased value-added advice, more tailored to country circumstances, more solidly anchored in the empirical and analytical work, and strengthen synergies with surveillance. This policy paper sketches a multi-year strategy to address frequently asked questions related to CBDC and outlines the process for developing a CBDC Handbook, which will document emerging lessons, analytical findings, and the policy views. In brief, the policy paper (1) explains the IMF's approach to CBDC CD; (2) summarizes member countries' emerging questions and challenges regarding CBDC; and (3) introduces the CBDC Handbook by motivating its scope and elucidating its governance structure.

各位股東:

本人謹代表賽伯樂國際控股有限公司(「賽 伯樂」或「本公司」,連同其附屬公司統稱 「本集團」)董事會(「董事會」),欣然提呈 本集團截至二零二二年十二月三十一日止 年度之年報。

近年來,國際貨幣基金組織看到全球對中 央銀行數碼貨幣(央行數碼貨幣)的興趣 達到前所未有的水平。近期的調查為央行 數碼貨幣的廣泛勘探及其背後的理由提供 見解。就國際貨幣基金組織在今年四月發 佈的《央行數字貨幣能力開發方針》政策 文件而言,全球央行正在積極探索央行數 碼貨幣,這可能對國內和國際經濟及金融 穩定程度產生根本性影響。全球40多個 國家已接洽國際貨幣基金組織,要求國際 貨幣基金組織透過央行數碼貨幣能力開發 提供協助;而目前國際貨幣基金組織的央 行數碼貨幣能力開發的工作集中於促進同 業學習及發展分析基礎,以便員工向成員 國提供建議。能力開發使命旨在幫助國家 當局回答有關如何思考央行數碼貨幣的問 題。隨著有更多可用的國家實驗及實證證 據,國際貨幣基金組織的能力開發將不斷 發展,以提供更多增值建議、更切合國家 情況、更紮實地立足於實證及分析工作, 並加強與監測的協同效應。此政策文件草 擬了一個多年的策略,旨在解決與央行數 碼貨幣有關的常見問題,並概述了開發央 行數碼貨幣手冊的過程,該手冊將記錄新 的課程、分析結果及政策觀點。概括而 言, 政策文件(1) 闡述國際貨幣基金組織 對央行數碼貨幣能力開發的方針;(2)概述 成員國就央行數碼貨幣提出的新問題及挑 戰;及(3)通過闡明其範圍和闡述其治理結 構引入央行數字貨幣手冊。



On 11 April 2023, the World Economic Outlook Update of the IMF reported that the Global economic activity is experiencing a broad-based and sharper-than-expected slowdown, with inflation higher than seen in several decades. The cost-of-living crisis, tightening financial conditions in most regions, the Russia-Ukraine war, and the lingering Covid-19 pandemic all weigh heavily on the outlook. Global growth is forecast to slow from that of 3.2 percent in 2022 to 2.7 percent in 2023. This is the weakest growth profile since 2001 except for the global financial crisis and the acute phase of the Covid-19 pandemic. "There are also stark differences between country groups." said by Kristalina Georgieva, IMF Managing Director (MD), at Washington, DC in her speech to address on issues on April 6, 2023, "Some momentum comes from emerging economies where Asia especially is a bright spot. India and China are expected to account for half of global growth in 2023, but others face a steeper climb. Economic activity is slowing in the United States and the Euro Area, where higher interest rates weigh on demand. About ninety percent of the advanced economies are projected to see a decline in their growth rate this year." For the low-income countries, there are higher borrowing costs come at a time of weakening demand for their exports; and their per-capita income growth will stay below that of the emerging economies. That is a severe blow to them, making it even harder for the low-income nations to catch up this year. She also commented that poverty and hunger could further increase, with a dangerous trend that was started by the Covid crisis. We know that the strong and coordinated monetary and fiscal policy actions over the past years had prevented a much worse outcome. But with the rising geo-political tensions and still-high inflation, a robust recovery remains elusive. This harms the prospects of everyone, especially for the most vulnerable people and their countries.

於二零二三年四月十一日,國際貨幣基金 組織的《世界經濟展望更新》報告指出, 全球經濟活動正在經歷廣泛且比預期更為 嚴重的放緩,通貨高於數十年來的水平。 生活成本危機、大部分地區的財務環境收 緊、俄烏戰爭及持續肆虐的Covid-19疫 情均對前景造成沉重壓力。預計全球增長 將由二零二二年的3.2%放緩至二零二三 年的2.7%。除全球金融危機及Covid-19 疫情的嚴重時期外,此乃二零零一年以 來最疲弱的增長。「國家集團之間亦存在 巨大差異。」國際貨幣基金組織董事總經 理Kristalina Georgieva於二零二三年四月 六日在華盛頓哥倫比亞特區舉行的演講中 表示:「新興經濟體尤其是亞洲地區為一 股強勁動力。預期印度及中國將於二零二 三年佔全球一半的增長,但其他地區則面 臨更陡峭的攀升。美國及歐元區的經濟活 動正在放緩,利率上升對需求構成壓力。 預計今年約有百分之九十的發達經濟體增 長率將會下降。」就低收入國家而言,在 出口需求疲弱的情況下,借款成本較高; 他們的人均收入增長將繼續低於新興經濟 體。這對他們造成沉重打擊,令低收入國 家於本年度更難追趕其他國家。她亦表 示,貧困及飢餓的情況可能會進一步增 加,這是由Covid危機開始的危險趨勢。 我們明白,過去數年強勁而協調的貨幣及 財政政策行動已防止更不利的結果。然 而,隨著地緣政治緊張局勢加劇及通脹仍 然高企,仍難以實現強勁的復甦。這對每 個人的前景,尤其是對最弱勢的人民及其 國家造成損害。



With the whole country sticked to its "Zero-Covid" policy during 2022, China is combating significant downward pressure economically with multiple cities implementing some form of lockdown since March 2022, and the most notorious of which was the lockdown of approximately two months in Shanghai. The Covid-19 prevention and control measures in China have seriously disrupted production processes and distressed the worldwide supply chain, while other headwinds such as the ongoing Russian-Ukraine conflict, have only exacerbated China's economic vulnerabilities. Therefore, the Chinese government has ramped up different stimulus measures to boost its economy, including urging the country's financial system to support the private sector, implementing preferential tax policies and fee cuts, and increasing government spending and investment to indirectly support the real economy. According to the data released by the National Bureau of Statistics of China (NBS), the country's total GDP in 2022 reached RMB121.02 trillion, an increase of 3.0 percent over last year at constant prices. In the World Economic Outlook released in April, the IMF forecasted China's growth to stay at 5.2 percent this year, a 0.8 percentage point revision to the IMF's October 2022 projection, as it said that the world is experiencing a "rocky recovery". "We have been pleased to see this rebound of China not only for China, of course for the world, but also because of China's role in the world economy," Kristalina Georgieva, the IMF MD told the public in a news conference at the Spring meetings between IMF and the World Bank. "China this year is going to contribute about one-third of global growth. We calculated that with one (1.0) percent more growth in China translates into 0.3 percent more growth for the economies that are connected to China," the IMF Chief also said. And according to the Chairman of the Standard Chartered Bank, José Viñals, China's economy will be "on fire" in the second half of 2023 as the economic performance of East and West diverges. He has commented that the reopening of the Chinese economy following the previous several years of strict "Zero-Covid" measures has buoyed sentiment among economists that the global growth and inflation picture may be less bleak than initially feared this year. And in the 14th PRC National People's Congress, Chinese Premier Li Keqiang said at a meeting with the PRC officials of the National Development and Reform Commission and the Ministry of Finance on February 23 that the nation's economic growth is rebounding steadily; and the recovery of consumption accelerated and market expectations rebounded significantly in the first two months of 2023.

隨著二零二二年全國嚴格實施「清零」政 策,中國經濟正面臨巨大的下行壓力,自 二零二二年三月起多個城市實施若干形式 的封城,其中最令人擔憂的是上海封城約 兩個月。中國的Covid-19防控措施已嚴重 干擾生產過程,並擾亂全球供應鏈,而其 他不利因素(如俄羅斯與烏克蘭的持續衝 突)僅加劇中國經濟的脆弱性。因此,中 國政府已採取不同刺激經濟措施,包括敦 促國家金融體系支持私營機構、實施優惠 税收政策及減費,以及增加政府支出及投 資以間接支持實體經濟。根據中國國家統 計局公佈的數據,二零二二年中國國內生 產總值達人民幣121.02萬億元,按固定 匯率計算較去年增長3.0%。在四月發佈 的《世界經濟展望》中,國際貨幣基金組 織預測今年中國的增長將保持在5.2%, 這是對國際貨幣基金組織二零二二年十月 預測作出0.8個百分點的修訂,因為其指 出全球正在經歷「驚人的復甦」。國際貨 幣基金組織總經理Kristalina Georgieva在 國際貨幣基金組織和世界銀行的春季會議 新大會上對公眾表示:「我們很高興看到 中國經濟的反彈,這不僅是為了中國,當 然也是為了全世界,同時也是因為中國在 世界經濟中的角色。」國際貨幣基金組織 總裁亦道:「今年,中國將貢獻全球三分 之一的增長。我們計算出,中國增長每增 加1.0%,將會為與中國有關聯的經濟體 帶來0.3%的增長。」據渣打銀行主席José Viñals所言,由於東西部經濟表現分化, 中國經濟將於二零二三年下半年繁榮興 盛。彼表示,中國經濟於過去數年實施嚴 格的「清零」措施後重新開放,令經濟學 家的情緒得以提振,全球增長及通脹前景 可能較今年最初預期的要好。而在第十四 屆中國全國人民代表大會上,中國總理李 克強在二月二十三日與國家發展和改革委 員會及財政部的中國官員的會議上表示, 中國經濟增長正穩步回升;於二零二三年 首兩個月,消費復甦步伐加快,市場預期 顯著反彈。



In Hong Kong, the GDP of year 2022 decreased by 3.5 percent in real terms from 2021. And the Hong Kong Government forecasts economic growth of 3.5 percent to 5.5 percent in real terms for year 2023. The overall consumer prices rose by 1.7 percent in February 2023 over a year earlier. Considering that inflation is likely to remain relatively contained, the Government forecasts Hong Kong's underlying consumer price inflation at around 2.5 percent for 2023. The value of retail sales, in nominal terms, increased by 7.0 percent year-on-year in January 2023 over that of the same month a year earlier. Additionally, the Secretary for Hong Kong Financial Services and the Treasury, Mr. Christopher Hui has commented in his recent speech that the Hong Kong Government will continue to review regulatory measures for money lenders, promulgate the importance of prudent borrowing through public education, and induce more responsible lending behaviours among money lenders in order to protect the public interest. Moreover, Hong Kong borrowers will need to dig deeper to pay off their mortgages and other loans as commercial banks are set to increase their interest rates further in 2023, after the U.S. Fed has planned to increase the interest rate.

The Company has three reporting segments, which are separately managed with different business strategies, as each subsidiary business offers different products and services to meet the market needs. Amongst them the segment business of money lending maintained steady business growth and generated good revenue stream for the Group during 2022. The electronic commerce (eCommerce) subsidiary business faced with difficulties to achieve performance due to the global uncertainties on the continual delay of flights, country lockdowns, additional regulatory and market platform restrictions etc. resulted from the Covid-19 pandemic during the year under review. Unfortunately, the online education business segment originally operated for tutoring in China was suspended in 2022, and it is expected that the subsidiary segment will resume new business operation at the completion of restructuring process for the subsidiary segment later this year.

在香港,二零二二年的本地生產總值較 二零二一年實質下降3.5%。香港政府預 測二零二三年經濟實質增長為3.5%至 5.5%。二零二三年二月的整體消費物價 較去年上升1.7%。考慮到通脹可能維持 相對穩定,政府預測二零二三年香港的 相關消費物價通脹約為2.5%。按面值計 算,二零二三年一月的零售銷售額較去年 同比增長7.0%。此外,香港財經事務及 庫務局局長許正宇先生在其近期的演講中 表示,香港政府將繼續檢討放債人的監管 措施,透過公眾教育宣揚審慎借貸的重要 性, 並引導放債人採取更負責任借貸行 為,以保障公眾利益。此外,由於美國聯 邦儲備局計劃上調利率後,商業銀行將於 二零二三年進一步上調利率,故香港借款 人將需要更加努力償還他們的按揭及其他 貸款。

本公司擁有三個報告分部,由於各附屬公 司業務提供不同產品及服務以滿足市場需 求,故按不同業務策略分開管理。其中, 放債分部業務於二零二二年維持穩定業務 增長,並為本集團帶來良好收入來源。由 於回顧年度內Covid-19疫情導致航班持續 延誤、國家封城、額外監管及市場平台限 制等方面的全球不明朗因素,電子商務附 屬公司業務難以實現業績。不幸的是,原 本於中國經營培訓的線上教育業務分部於 二零二二年暫停營運,預期該附屬公司分 部將於今年稍後時間完成重組程序後恢復 新業務營運。



In recent years, the Chinese government has implemented tight measures to regulate the total social financing (TSF) and the online financial services, particularly on peer-to-peer (P2P) lending activities. Although the lending business model under P2P is very simple and easy to establish, the lending business in Hong Kong is under the financial environment of very distinctive regulated market features to the lending business operation in China. Despite the global economic uncertainty and the increasing market competition of the money lending industry in Hong Kong, the loan demand in Hong Kong are still robust. With the impacts from the U.S.-China trade war and the waves of the Covid-19 pandemic in Hong Kong, our money lending subsidiary operated in Hong Kong had maintained better business relationship with partnership alliance for sub-mortgage loans on high net worth customers and through referrals during 2022. And the subsidiary business group will continue its existing network and strategies to extend the business growth in 2023.

In recent years, the eCommerce platforms have driven business activities with various new add-on features and in-app functions, while images and videos on social media have strongly influenced on consumers' purchase intent. The mobile commerce application has become one of the most effective strategies for business growth in today's eCommerce, and mobile shopping is in an emerging trend that still requires further improvement to operate effectively. During 2022, our eCommerce subsidiary group had adopted different marketing strategies to enhance sales through exposure in the social media and via different eCommerce platforms. The market demand was quite distorted and business reduced because of the prolong U.S.-China trade battle and the Covid-19 variant pandemic, which resulted to the shortage and delays in product supplies and deliveries. Facing the adverse situations due to the logistic delays and harsh new platform restrictive requirements etc., our eCommerce subsidiary strived quite hard for business revenue and market share in the highly competitive eCommerce market in 2022.

近年來,中國政府已實施嚴格措施,以監 管社會融資總額及線上金融服務,尤其是 個人對個人貸款活動。儘管個人對個人之 借貸業務模式相當簡單,亦易於建立,與 之相比,香港借貸業務則為非常具有特色 並受市場格局規管。儘管世界經濟不明 朗,加上香港放債行業市場競爭日趨激 烈,但香港貸款需求依然強勁。受中美貿 易戰及香港Covid-19疫情所影響,我們於 香港經營的放債附屬公司於二零二二年與 影路集團將繼續其現有網絡及策略,以於 二零二三年擴大業務增長。

近年來,電子商務平台通過各種新的附加 功能及應用程式內置功能推動業務活動, 而社交媒體上的圖像及視頻嚴重影響消費 者的購買意向。移動商務應用程式已成為 現今電子商務業務增長的最有效策略之 一,而手機購物是一種新興趨勢,但仍需 要進一步改進才能有效運作。於二零二二 年,我們的電子商務附屬公司集團採取不 同的營銷策略,通過社交媒體的曝光及透 過不同的電子商務平台來提高銷售額。由 於中美貿易戰及Covid-19變種病毒疫情持 續,導致產品供應及交付短缺及延誤,市 場需求嚴重扭曲,業務因而減少。面對物 流延誤及嚴格的新平台限制要求等不利情 況,我們的電子商務附屬公司於二零二二 年在競爭激烈的電子商務市場上努力獲取 業務收入及市場份額。

Education in China is managed by the state-run public education system and regulated under the Ministry of Education. It has been more than a year since China introduced its draconian education reform policies in late July 2021, on the areas for Further Reducing the Burden of Compulsory Education Students' Homework and Off-campus Training with After School Tutoring. Since then, many of China's most prominent online tutoring firms have either shut, downsized or pivoted to alternative businesses under the educational reforms and regulations on after school tutoring services. Until 2021, after-school tutoring was the most active and lucrative business segment, attracting capital investment and involving numerous private companies. In brief, reconfiguration has been ongoing in China's education sector. Strategic business transformation in all Chinese companies in the education sector is an ongoing challenge.

In April 2022, the revised Vocational Education Law upgraded the status of the education business segment in PRC, and the law revision states that China should have a modern vocational education system by 2025. The rapid growth of vocational training has led to thousands of new market entrants, most of them are the domestic players, while the prospects for commercial collaboration can be plenty for foreign companies and investors finding the right partners for the education business in China. After reducing its market size and cutting off the link to profit making, online tutoring business in China will no longer be a systemic problem in education service. To comply with the new regulatory requirement to provide education services in China, we have temporarily suspended the operation of our online education services since July 2021. In fact, we are aiming for future engagement in education related business including provision of vocational trainings and similar activities for students and adults. In the meantime the subsidiary group is undergoing its restructuring for the new business operation be registered to provide such services, so that we can still maintain our education subsidiary and have it engaged for another income stream for the Group in near future.

中國的教育由國家營辦的公共教育制度管理,並受教育部規管。自中國於二零二一年七月底引入針對《關於進一步減輕義務 教育階段學生作業負擔和校外培訓負擔的 意見》的教育改革政策以來,已有一年多 的時間。自此,根據教育改革及有關校外 培訓公司已關閉、縮減規模或轉向其化 勝務的法規,許多中國最知名的線上 培訓公司已關閉、縮減規模或轉向其活躍 及最豐厚的業務分部,吸引資本投資教育 及眾多私營公司。簡而言之,中國教育行 業正在進行重新配置。在中國教育行業, 所有公司的戰略業務轉型都是一項持續的 挑戰。

於二零二二年四月,經修訂的職業教育法 提升了中國教育業務分部的地位,而法律 修訂規定中國應於二零二五年前擁有現代 職業教育體系。職業培訓的快速增長導致 成千上萬的新市場參與者,其中大部分為 國內參與者,而對於尋找在中國教育業務 上的合作夥伴的外國企業和投資者而言, 商業合作前景可謂非常豐富。在縮減市場 規模及與盈利無關後,中國的線上培訓業 務將不再是教育服務的系統性問題。為遵 守在中國提供教育服務的新監管規定,我 們自二零二一年七月起暫停運營我們的線 上教育服務。事實上,我們旨在於未來從 事教育相關業務,包括為學生及成人提供 職業培訓及類似活動。同時,附屬公司集 團正進行重組,以註冊新業務營運以提供 有關服務,因此我們仍可維持教育附屬公 司, 並在不久將來為本集團帶來另一收入 來源。

MARKET REVIEW

In the January 2023 World Economic Outlook (WEO) Update, the International Monetary Fund (IMF) projected the global economic growth to fall from an estimated 3.4 percent in 2022 to 2.9 percent in 2023, then it might rise to 3.1 percent in 2024. Global inflation is expected to fall from 8.8 percent in 2022 to 6.6 percent in 2023 and then to 4.3 percent in 2024. It mentioned that the rise in the U.S. central bank rates to fight for inflation in U.S. and the Russia's war in Ukraine continue to weigh on the global economic activities. The rapid spread of Covid-19 in China dampened global economic growth in 2022, but the recent reopening has paved the way for a faster-thanexpected recovery in 2023. The balance of risks remains tilted to the downside of the global economy, as Russia's war in Ukraine could escalate, and tighter global financing costs could worsen debt distress. Financial markets could also suddenly reprice in response to adverse inflation news, while further geopolitical fragmentation could hamper the global economic progress.

Faced with the complicated, unstable changing global economic and political environments, while with vaccination and efforts in the prevention and control of Covid-19 epidemic, the global economy was somehow distorted and volatile in the financial market worldwide during 2022. According to China National Bureau of Statistics (NBS), the Chinese economy in 2022 had a slight expansion with the gross domestic product (GDP) of 3.0 percent growth over the previous year, amidst the trade war with the United States, the drastic impacts of the Covid-19 pandemic, the disruptions in global supply chain and efforts to deleverage debt and financial risks in the economy. As commented in the bureau statement by Mr. Sheng Laiyun, the deputy director of China NBS in February 2023, "Despite the headwinds from both at home and abroad, China's GDP in 2022 was RMB121.02 trillion yuan, up by 3 percent over the 2021." The estimated figures from the China NBS showed that the total added value for all industries exceeded RMB40 trillion yuan for the first time in 2022; and the added value of the manufacturing sector reached RMB33.5 trillion yuan, showing that China maintained its status as the leading manufacturing

市場回顧

面對複雜多變的全球經濟及政治環境, 在進行疫苗接種及Covid-19疫情防控工 作的同時,全球經濟於二零二二年在全 球金融市場上受到一定程度的扭曲及波 動。根據中國國家統計局的資料,二零二 二年中國經濟略有增長,在與美國貿易 戰、Covid-19疫情的嚴重影響、全球供 應鏈中斷等情況及經濟去槓桿化債務及金 融風險的努力下,國內生產總值較去年增 長3.0%。二零二三年二月,中國國家統 計局副局長盛來運先生在統計局公報中表 示:「儘管國內外形勢不利,二零二二年 中國國內生產總值為人民幣121.02萬億 元,較二零二一年增長3%。」中國國家統 計局的估計數字顯示,二零二二年所有行 業的總增值首次超過人民幣40萬億元; 製造業增值達人民幣33.5萬億元,顯示 二零二二年中國繼續保持全球領先的製造 業中心地位。盛先生亦評論道:「中國經 濟增長韌性較強,潛力巨大,支撐高質量



hub in the world in 2022. Mr. Sheng also commented, "China has a strong resilience in economic development with huge and vigorous potential, while all the factors supporting the highquality development remain unchanged. China has the strong and steady basis in economy, self confidence and capability to withstand various challenges, despite the uncertainties resulting from complex external factors such as a contraction in domestic demand, supply disruptions and weakening expectations." It was noted that the added value of industries above designated size increased by 3.6 percent in 2022 over the previous year; and the value added of the wholesale and retail trades was up by 0.9 percent over 2021. The additional information from the China NBS for the year 2022 also showed that the fixedasset investment of the country increased by 4.9 percent yearon-year; and on its average estimation, the producer price of industrial products decreased by 1.4 percent over the same period of last year, and the purchasing price of industrial products increased by 7.6 percent.

The Hong Kong economy weakened notably and experienced recession in 2022. The Hong Kong GDP contracted by 3.5 percent in real terms, while having that expanded visibly by 6.4 percent in the preceding year. As the private consumption plunged due to the fifth wave of the local Covid-19 epidemic, real GDP contracted by 3.9 percent year-on-year in the first quarter of 2022. During the year there was a fall moderated to 1.2 percent in the second quarter as the epidemic stabilised, but widened to 4.6 percent and 4.2 percent in the third and fourth quarters respectively as the deteriorated external environment and tightened financial conditions weighed on exports of goods and fixed asset investment. The sharply deteriorated external environment and the disruptions to crossboundary truck movements between Hong Kong and the Mainland China dealt a heavy blow to Hong Kong's goods exports in 2022. Exports of services from Hong Kong declined slightly in 2022 alongside the difficult external environment, though inbound tourism showed some revival towards the end of the year. And the Hong Kong domestic demand was dampened first by the fifth wave of the local epidemic and then affected by the tightened financial conditions in 2022.

香港經濟顯著疲弱,並於二零二二年出 現衰退。香港本地生產總值實質下跌 3.5%,而上個年度則顯著增長6.4%。由 於本地第五波Covid-19疫情導致私人消 費暴跌,二零二二年第一季度的實際本 地生產總值同比下降3.9%。年內,隨著 疫情漸趨穩定,第二季度的跌幅放緩至 1.2%,但由於外圍環境轉差及金融環境 收緊令貨物出口及固定資產投資受壓, 第三季度及第四季度的跌幅分別擴大至 4.6%及4.2%。於二零二二年,外圍環境 急劇惡化及香港與中國內地之間跨境貨車 流動受阻,對香港貨物出口造成嚴重打 擊。二零二二年,香港的服務出口因外圍 環境困難而輕微下跌,但入境旅遊則於年 底出現復甦。而香港本地需求首先受到本 地第五波疫情的打擊,其後受到二零二二 年緊縮的財務狀況影響。



In China, the massive collapse of the virtual lending platforms for online social lending in China has spread panic among stakeholders in recent years. With the restrictive government regulations on the online social lending industry in China, a slew of Chinese fintech and social lending platforms have sought for expansion in lenient markets in Southeast Asia. The lending business in China are of huge potential but having higher risks than that in Hong Kong, and both markets have very distinctive regulatory requirements for their business operation. The Hong Kong Government has adopted a four-pronged approach to enhance the compliance standards of non-bank money lenders since 2016; and Hong Kong continues to have an active and growing money lending market. In 2021, the Hong Kong Government enhanced conditions on money lenders licences, including requiring money lenders to undertake an assessment of the borrower's ability to make repayments and have due regard to the outcome of the assessment before entering into a loan agreement for an unsecured personal loan. Besides, the regulations of advertisements of money lenders and protection of loan referees were also enhanced. The Hong Kong government has always reminded borrowers on the risks while borrowing, and all money lenders must operate business in strict compliance with Money Lenders Ordinance and license restrictions. "There are growing concerns about interest rates charged on lending in recent years, including fears that the excessively high interest would harm the borrowers, particularly those with low incomes, and the consequence might lead to other social problems." once said by the Secretary for Hong Kong Financial Services and the Treasury, Mr. Christopher Hui in public. Mr. Hui welcomed the passage of the amendments to the Money Lenders Ordinance by the Legislative Council on October 26, 2022. According to the Amended Lenders Ordinance, which takes effect from December 30, 2022 that the statutory interest rate cap for lending in Hong Kong will be lowered from 60 percent to 48 percent per annum, while the threshold of extortionate rate will be lowered from 48 percent to 36 percent per annum.

在中國,近年來中國線上社交借貸虛擬借 貸平台的大規模崩潰已在持份者之間傳播 恐慌。由於政府對中國線上社交借貸行業 的監管限制,中國眾多金融科技及社交借 貸平台已尋求於寬鬆的東南亞市場拓展。 與香港市場相比,中國的借貸業務潛力巨 大,但風險也更大,而且兩個市場對業務 營運的監管要求也截然不同。自二零一六 年起,香港政府已採取四項措施提升非銀 行放債人的合規標準;而香港的放債市場 繼續活躍且不斷增長。於二零二一年,香 港政府加強對放債人牌照的條件,包括要 求放債人對借款人的還款能力進行評估, 並於訂立無抵押私人貸款的貸款協議前充 分考慮評估結果。此外,其亦加強對放債 人廣告的監管及對貸款轉介人的保障。香 港政府一再提醒借款人借款風險,所有放 債人必須嚴格遵守放債人條例及牌照限制 經營業務。香港財經事務及庫務局局長許 正宇先生曾公開表示:「近年來,對放債 利率費用的擔憂日益增加,包括擔心高息 會損害借款人,尤其是收入較低的借款 人,並可能導致其他社會問題。」許先生 歡迎立法會於二零二二年十月二十六日通 過對放債人條例作出的修訂。根據於二零 二二年十二月三十日生效的經修訂放債人 條例,香港貸款的法定利率上限將由每年 60%下調至48%,而優惠利率的下限將由 每年48%下調至36%。

In recent years, the retail industry has faced a multitude of changes. While the adoption of the digital technology has brought of innovation, specific retail formats such as convenience and franchise stores are growing significantly faster than others. The retail market for fast-moving consumer goods is highly affected by the rise of eCommerce and that shifts in consumer behaviour, such as an increasing demand for multiple delivery and collection options. The lockdowns, travel restrictions, social hygiene and distance, and government regulations on group gathering prohibitions etc. in response the pandemic of the Covid-19 variants in different countries have greatly affected the daily life and business activities of their people. The restrictive measures by the different countries on flight and local transport have posed serious logistic problems and losses to consumers and eCommerce business. In fact, eCommerce activity in different countries has seen a huge jump over the past three years, resulted from the Covid-19 pandemic forcing customers to seek alternative means to browse for buying, due to lockdowns, store closures and other hygiene restrictions etc. Further, consumers are now getting accustomed to use internet and mobile apps daily for online shopping where, they can have the practical innovative features and bonus being adopted by eCommerce sites through trusted, secure digital wallets. Amongst the three major eCommerce markets - the U.S., China and Europe - in the globe, China was the biggest eCommerce market in 2022; and analysts expect that China will stay in the lead in eCommerce market through 2027. In 2022, the Chinese eCommerce market was of US\$1,156.3 billion with electronic products being the biggest segment; revenues generated in the U.S. market were of US\$904.9 billion; and Europe as the third biggest eCommerce market with revenues of US\$662.5 billion.

近年來,零售業面臨諸多變化。儘管採用 數碼技術帶來創新,但便利及特許經營店 等特定零售業態的增長速度明顯高於其他 零售業態。快速消費品的零售市場受到電 子商務興起及消費者行為轉變(如對多種 交付及收款選擇的需求不斷增加)的嚴重 影響。為應對不同國家的Covid-19變異株 疫情而實施的封城、出行限制、社交衛生 及距離,以及有關禁止群組聚集的政府法 規等,大大影響了各國人們的日常生活及 商業活動。不同國家對飛行及本地運輸實 施的限制措施已對消費者及電子商務業務 造成嚴重物流問題及損失。事實上,於過 去三年,由於Covid-19疫情導致封城、店 舖關閉及其他衛生限制等,迫使客戶尋求 其他途徑瀏覽購物,導致不同國家的電子 商務活動大幅上升。此外,消費者現時習 慣每日使用互聯網及手機應用程式透過可 靠及安全的電子錢包進行網上購物,彼等 可享用電子商務網站採用的實用創新功能 及花紅。在全球三大電子商務市場-美 國、中國及歐洲中,中國為二零二二年最 大的電子商務市場;且分析師預期,中國 於二零二七年將保持電子商務市場的領先 地位。於二零二二年,中國電子商務市場 規模達11,563億美元,其中電子產品佔最 大份額;美國市場收入為9,049億美元; 而歐洲為第三大電子商務市場,收入達 6,625億美元。



In China, year 2021 marked the start of a new era in the country's education reform, particularly in after-school tutoring, which was once worth as an industry of US\$112 billion. The government regulatory restrictions are one of the most challenging issues always faced by the education companies and providers in China. In early July 2021, the China government imposed *shuangjian* (literally meaning "double reduction") policy, a set of government policies that aimed to decrease the work pressures of children, such as banning extra-curricular tutoring services from operating during weekends and hiring overseasbased teachers for online learning in China. The "double reduction" policy had caused a tsunami in the capital markets since July 2021, leaving many of the tutoring companies to struggle hard for survival. Edtech companies plunged after the China Ministry of Education published a new set of restrictions that limit the fees and operating times of private tutoring services for primary and middle school students. The after-school tutoring business in China was the most active and lucrative segment in education industry, attracting capital investment and involving numerous private companies before July 2021, since education is managed by the state-run public education system and regulated under the China Ministry of Education.

Since the second half of 2021, the China Ministry of Education had introduced several new measures, including the new standard for Chinese proficiency in language education, the teaching reform guidelines for physical education and health education, and the further promotion of vocational education etc. In fact, the vocational training in China has become an important driving force for stabilising the education sector in recent years. Favourable educational reforms and policies are boosting further development in this area, which in turn will provide opportunities for the fast growing companies; such that they can participate in the activities as trainings for the skilled work in new materials for the development and advanced manufacturing. In April 2022, the introduction of the Revised Vocational Education Law by the China Ministry of Education had upgraded the importance of vocational education in China. The revised law on vocational education scope and guideline encourages traditional secondary schools to offer courses on vocational education subjects, so that the vocational education graduates can have equal education and career opportunities as others.

BUSINESS REVIEW

In 2022, the Cybernaut Group comprised three segments of subsidiary groups, namely those engaged in the money lending business; eCommerce business and internet online education services.

The subsidiary of Cybernaut Group engaged in money lending business in Hong Kong under the Money Lenders Ordinance ("MLO", Chapter 163 of the Laws of Hong Kong), Time Credit Limited (TCL) prudently maintained business operation steadily with the existing market strategy in 2022. During the year under review, the subsidiary generated revenue by granting the first mortgage property loans to customers for their financial needs. In fact, Hong Kong government authority has periodically advised borrowers to be aware of the unstable and uncertain economic environment and the risks of increased interest rate etc. through media. The Hong Kong Monetary Authority (HKMA) raised the base rate by 50 basis points to 4.75 percent on December 15, 2022 the seventh rate hike in 2022, just in hours after the U.S. Federal Reserve delivered a similar rate hike to stick with efforts to cool its surging inflation. Our subsidiary group, TCL does not deal with SME loans at retail level, but the customer basis of potential borrowers from the social and business networks of the management and marketing team. TCL has good credit control efficiency with clientele mainly composed of the high net worth customers or through the recommendation by the partnership alliance on sub-mortgage arrangements. TCL has kept its loan portfolio of clients of good standings such as the Hong Kong Listco and big corporate clients. During 2022, TCL contributed a steady income stream to the Cybernaut Group though facing with the reduced business under the Covid-19 pandemic.

業務回顧

二零二二年,賽伯樂集團包括三個分部, 即從事放債業務、電子商務業務和互聯網 線上教育服務的附屬集團。

根據香港法例第163章《放債人條例》(「放 債人條例」)在香港從事放債業務的賽伯樂 集團附屬公司友邦信貸有限公司(TCL)於 二零二二年以現有市場策略審慎維持業務 營運。於回顧年內,該附屬公司透過向客 戶提供滿足其財務需求的首次按揭物業貸 款產生收入。事實上,香港政府當局已定 期透過媒體提醒借款人注意不穩定和不確 定的經濟環境以及加息等風險。於二零二 二年十二月十五日,香港金融管理局將基 準利率上調50個基點至4.75%。二零二二 年的第七次利率上調僅於美國聯邦儲備局 發出類似加息通知後的數小時內進行,以 繼續努力為其激增通脹降溫。我們的附屬 集團TCL並不處理零售層面的中小企業貸 款,而是管理及營銷團隊的社交及業務網 絡中的潛在借款人客戶基礎。TCL擁有良 好的信貸控制效率,其客戶主要包括高淨 值客戶或透過次級抵押貸款合作夥伴關係 所推薦的客戶。TCL的貸款組合持續以信 譽良好的客戶(如香港上市公司及大型企 業客戶)組成。於二零二二年,儘管面對 Covid-19疫情導致的業務減少,TCL為賽 伯樂集團帶來穩定的收入來源。

Realized that the online marketplaces are booming vastly and highly competitive, our eCommerce business subsidiary group with the trade name "VTZero" strived extremely hard to meet its overseas market demand under the Covid-19 pandemic and the tough global economic fluctuation during 2022. The various revised restrictions of fund retention requirement, logistics, and business policy changes issued by the different online market platforms in 2022, had created further hardship for VTZero to maintain steady business and generate revenues in the product sales of the refurbished second-handed mobile phones of good brand names. Besides, the absence and bans on hygiene arrangement and international flight in both Hong Kong and overseas had further increase the burdens to provide punctual delivery of goods to our consumers. During 2022, VTZero not only had to face the fluctuated global market product price competition resulted mainly from the U.S.-China trade war and the Covid-19 pandemic, but also encountered sudden need to pay high cost for the unusual logistic arrangements for the punctual delivery of our products to the customers as we have once promised.

Followed the July 2021 shuangjian (literally meaning 'double reduction') Beijing government policy imposed in China and to comply with the government measures of the New and Revised Education Regulations to reduce the burden of homework and after school tutoring on students in compulsory education, our subsidiary business providing online after-school tutoring services for academic subjects to students in PRC by 京師沃 學(北京)教育科技有限公司 Capital Wowxue (Beijing) Education Technology Limited (沃學"Wowxue"), which was once operated under the arrangement of the VIE Agreements with 湖州公 司 Huzhou Company, the wholly-owned subsidiary of the Company in China, was temporarily ceased with operation suspended since July 2021. The subsidiary business will be resumed for restart when the new regulatory requirements of education is clear enough for us to follow. The ICP license was surrendered to the regulatory department and cancelled in 2022. The VIE arrangement by Huzhou with Wowxue will become invalid when all the binding contracts under the arrangement are gradually modified and fully cancelled at the time when the corporate restructuring of having Wowxue become a subsidiary of the Company group is completed in 2023. We realize that the temporary business suspension of the

遵循二零二一年七月北京政府於中國實施 的「雙減」政策,並遵守為減輕義務教育 階段學生課業負擔及校外培訓負擔的新訂 及經修訂教育法規的政府措施,我們的附 屬公司業務由京師沃學(北京)教育科技 有限公司(「沃學」,曾根據與本公司的中 國全資附屬公司湖州公司訂立的可變利益 實體協議安排營運)向中國學生提供學科 線上校外培訓服務,其自二零二一年七月 起暫停營運。當教育的新監管規定足以讓 我們遵守時,附屬公司業務將恢復營運。 互聯網內容供應商牌照已於二零二二年交 回監管部門並註銷。當沃學成為本公司集 團附屬公司之企業重組於二零二三年完成 時,湖州與沃學訂立之可變利益實體安排 將於有關安排項下之所有具約束力合約被 逐步修訂及全面取消時失效。我們意識到 沃學暫停線上教育服務業務對本集團截至 二零二二年十二月三十一日止財政年度的 收入產生重大不利影響。在尋求專業判斷 及法律意見後,本公司管理層將繼續為附 屬公司分部探索教育相關業務的潛在項



online education services by Wowxue had a material adverse impact on the Group's revenues for the financial year ending 31 December 2022. With professional judgement and legal advice sought, the management of the Company will continue to explore potential projects on education related business for the subsidiary segment to restart once the restructuring processes are completed. During 2022, Wowxue had undergone series of restructuring process, and we are expecting a favourable outcome in mid 2023, for Wowxue to become a wholly-owned subsidiary, and as part of the Company Group engaged in education related business Wowxue can ultimately resume business from its currently suspended business operation.

An announcement was made by the Company on 11 January 2022, on the voluntary basis to keep the shareholders and other stakeholders of the Company informed of the latest development of the Group. The Group planned to carefully explore business potential to create more value for the shareholders that in view of the constantly increasing demand for location-based services in Hong Kong and the Asian-Pacific region, the Group has established a new business division for the relevant business of providing application of the technology of satellite data navigation and location-based services (the "New Business"). As at the date of the announcement, the Group primarily engaged in eCommerce business, internet education services and money lending business. The Board believes that with the popularisation of 5G internet, thriving development of portable internet, drone, and self-driving industries, and the emergence of a large number of digital map applications in particular, the demand and requirement for location information services are increasing day by day. There is demand for more accurate satellite location-based services in sectors such as smart city development, communication, the Internet of Vehicles, self-driving, the Internet of Things, engineering surveying, infrastructure maintenance, logistics, transportation and shipping as well as circumstances related to preventing and addressing sudden disasters. Accordingly, if the Group timely captures the valuable opportunity to commence the New Business, the Group can not only build a more diversified business portfolio, but also create more sources of income for the Group, which will in turn increase the interests of the Shareholders. We are of the view that commencing the New Business will be in the interest of the Company and the Shareholders as a whole.

本公司於二零二二年一月十一日作出自願 公佈,以知會本公司股東及其他持份者有 關本集團的最新發展。本集團計劃謹慎尋 找潛在商機,為股東創造更高價值,鑑於 香港及亞太地區對定位服務的需求不斷增 加,本集團已成立一個新的業務部門,提 供衛星數據及導航定位技術應用的相關業 務(「新業務」)。於該公佈日期,本集團 主要從事電子商務業務、互聯網教育服務 及放貸業務。董事會相信,隨著5G的網 絡普及、移動互聯網、無人機及自動駕駛 產業的蓬勃發展,尤其是電子地圖應用的 大量湧現,對位置資訊服務需求及要求與 日俱增。智能城市發展、通訊、智能車聯 網、無人駕駛、物聯網、工程測量、基建 維護、物流、交通、海運等產業及防範/ 應對特發災害等均需要更精準的衛星定位 服務。因此,若本集團能及時把握這寶貴 機會開展新業務,不僅使本集團更多元化 業務組合,而且能擴大集團收入來源,最 終為股東權益提升價值。我們認為,能於 現階段啟動開展新業務將符合本公司及股 東的整體利益。



Reference is made to the inside information of the Company dated 16 February 2022 in relation to the receipt of writ of summons. The Board announced on 15 February 2022, that VT Zero Limited ("Subsidiary Company"), a subsidiary of the Company, received a writ of summons issued in Court of First Instance of the High Court of the Hong Kong Special Administrative Region by AHS Device Hong Kong Limited as plaintiff against the Subsidiary Company as defendant. Pursuant to an Internet Sales Service Cooperation Agreement entered between the Plaintiff and the Subsidiary Company dated 1 August 2020 (the "Cooperation Agreement"), as set out in the indorsement of claim, the plaintiff claims against the Subsidiary Company, among others, for the liquidated sum of approximately HK\$25,800,000 being balance of the value of the plaintiff's goods sold through the Subsidiary Company in accordance with the Cooperation Agreement, return of the plaintiff's goods together with interest and costs. The Company has currently sought for legal advice and undergone the relevant court proceedings and is of the view that the claims made under the writ of summons has no merits and therefore will defend vigorously against them. The Company will keep its shareholders and investors informed of any significant development of the above proceedings and will make further announcement(s) as and when appropriate in accordance with the Listing Rule.

FINANCIAL REVIEW

Revenue

Money Lending

Even though the keen market competition and the wide spread of the Coronavirus Disease 2019 ("Covid-19"), the revenue of our money lending business increased by approximately 9.3% when comparing to 2021. The revenue contributed by this business was approximately RMB19.2 million for the year ended 2022 (for the year ended 2021: RMB17.5 million). 財務回顧

收入

放債

儘管市場競爭激烈及二零一九冠狀病毒病 (「Covid-19」)廣泛傳播,放債業務的收 入較二零二一年增加約9.3%。截至二零 二二年止年度,此業務貢獻的收入約為人 民幣19,200,000元(截至二零二一年止年 度:人民幣17,500,000元)。該增加乃主 要由於借貸利率上升所致。

ECommerce

The revenue contributed by this business was approximately RMB37.8 million for the year ended 2022 (for the year ended 2021: RMB102.8 million). The revenue decreased by approximately 63.2% is mainly due to price and supply fluctuation on second hand iPhone from USA; continuous logistics cost increase hits the margin; and logistics time to European warehouse unstable and mostly delay and hit the sales stability on marketplace. Also, with returns due to the defective products from our previous supplier, eCommerce business was negatively affected in sales channels, so inhibiting our exposure in marketplace and led to a small revenue size of business in the period under review.

Internet Education Services

As a result of the temporary business suspension of the internet education services which was acquired in November 2017, no revenue was contributed for the year ended 31 December 2022 (for the year ended 31 December 2021: RMB6.1 million). The subsidiary of internet education is now undergoing a new restructuring for its future business operation in the Group.

Cost of Sales/Service Rendered

The Group's cost of sales mainly comprised costs of raw materials, labour and other direct costs of sales and services rendered. During the year, the Group's cost of sales decreased by approximately 68.3% from RMB101.1 million in 2021 to approximately RMB32.1 million in 2022. The decrease is mainly due to the decrease of revenue of eCommerce business and the suspension of the internet education services business.

Gross Profit

The Group experienced a gross profit of approximately RMB24.9 million for the year ended 31 December 2022. For the year ended 31 December 2021, the Group recorded a gross profit of approximately RMB25.3 million. There was a slightly decrease of approximately 1.7% in gross profit. The gross profit was from the segment business in money lending and eCommerce business.

電子商務

截至二零二二年止年度,此業務貢獻的收入約為人民幣37,800,000元(截至二零二 一年止年度:人民幣102,800,000元)。 收入減少約63.2%乃主要由於來自美國的 二手iPhone的價格及供應浮動、物流成本 持續上升對利潤造成打擊;且到達歐洲倉 庫的物流時間不穩定,大部份時間出現延 誤,並打擊市場上銷售的穩定性所致。此 外,由於我們前供應商有缺陷的產品導致 退貨,電子商務業務在銷售渠道上受到負 面影響,從而抑制了在市場上的曝光率, 並導致回顧期內業務的收入規模較小。

互聯網教育服務

由於二零一七年十一月收購的互聯網教育 服務暫停業務,截至二零二二年十二月 三十一日止年度並無貢獻收入(截至二零 二一年十二月三十一日止年度:人民幣 6,100,000元)。互聯網教育之附屬公司 正就其於本集團的未來業務營運進行新重 組。

銷售/所提供之服務成本

本集團的銷售成本主要包括原材料成本、 勞工成本及銷售和所提供之服務的其他 直接成本。於本年度,本集團的銷售成 本自二零二一年的人民幣101,100,000元 減少約68.3%至二零二二年的約人民幣 32,100,000元。該減少乃主要由於電子商 務業務收入減少及互聯網教育服務業務暫 停營運。

毛利

本集團於截至二零二二年十二月三十一日 止年度錄得毛利約人民幣24,900,000元。 截至二零二一年十二月三十一日止年度, 本集團錄得毛利約人民幣25,300,000元。 毛利輕微下跌約1.7%。毛利來自放債及 電子商務業務的分部業務。



Other gains or loss, net

For the year ended 31 December 2022, the Group had issued convertible preference shares for the settlement of partial promissory notes and also extended the date of repayment of promissory notes, which generate the gain of approximately RMB86.9 million (for the year ended 31 December 2021: RMB64.4 million).

Impairments Loss

During the year under review, the Group had incurred the following major impairments:

- (a) Under the impact of the Covid-19 outbreak, it affected the repayment ability of the different industries. For the year ended 31 December 2022, impairment losses were recognized on trade and loan receivables of approximately RMB5.7 million (for the year ended 31 December 2021: RMB8.4 million).
- (b) No impairment loss was recognized on goodwill of eCommerce business and internet education services business for the year ended 31 December 2022 (for the year ended 31 December 2021: RMB212.4 million).
- No impairment loss was recognized on intangible assets of internet education services business for the year ended 31 December 2022 (for the year ended 31 December 2021: RMB52.8 million).

Selling and Distribution Costs

The Group's selling and distribution costs comprised sales commissions, sales staff costs and transportation costs. During the year, the cost increased by approximately 32.9% from approximately RMB1.6 million for the year ended 31 December 2021 to approximately RMB2.1 million for the year ended 31 December 2022. The increase is mainly due to the increase of transportation expenses in eCommerce business.

其他收益或虧損淨額

截至二零二二年十二月三十一日止年度, 本集團已發行可轉換優先股以結算部分承 兑票據,並延長承兑票據的還款日期,產 生收益約人民幣86,900,000元(截至二零 二一年十二月三十一日止年度:人民幣 64,400,000元)。

減值虧損

於回顧年度內,本集團已產生以下重大減 值:

- (a) Covid-19爆發已影響不同行業的 還款能力。截至二零二二年十二月 三十一日止年度,已就貿易應收款 項及應收貸款確認減值虧損約人 民幣5,700,000元(截至二零二一 年十二月三十一日止年度:人民幣 8,400,000元)。
- (b) 截至二零二二年十二月三十一日止 年度,並無就電子商務業務及互聯 網教育服務業務的商譽確認減值虧 損(截至二零二一年十二月三十一日 止年度:人民幣212,400,000元)。
- (c) 截至二零二二年十二月三十一日止 年度,並無就互聯網教育服務業務 的無形資產確認減值虧損(截至二零 二一年十二月三十一日止年度:人 民幣52,800,000元)。

銷售及分銷成本

本集團的銷售及分銷成本包括銷售佣金、 銷售員工成本及運輸成本。於本年度, 該成本由截至二零二一年十二月三十一 日止年度的約人民幣1,600,000元增加約 32.9%至截至二零二二年十二月三十一日 止年度的約人民幣2,100,000元。該增加 主要由於電子商務業務的運輸開支增加。



Administrative Expenses and Other Expenses

The Group's administrative expenses and other expenses decreased by approximately 24.8% from approximately RMB52.9 million for year ended 31 December 2021 to approximately RMB39.8 million for the year ended 31 December 2022. The decrease is mainly because no amortization of intangible assets is recognised for the year ended 31 December 2022 (for the year ended 2021: 12.4 million).

Finance Costs

The Group's finance costs composed of bank loans and promissory notes were approximately RMB54.1 million for the year ended 31 December 2022 (2021: RMB28.1 million). The increase is mainly due to the interest expense of the extension of promissory notes. The interest rate for bank loan for the years ended 31 December 2021 and 2022 were at a floating interest rate ranging from prime rate -2% or IBOR rate 1 month +3% whichever is lower to 7% per annum.

Taxation

The PRC subsidiary of the Company engaged in internet online education service provider still successfully qualified the China's High and New-Technology Enterprise (HNTE) program and obtained the Chinese High-tech Enterprise Certification (中國 高新技術企業認證) in 2017. Consequently, the subsidiary is entitled to the PRC Enterprise Income Tax ("EIT") rate of 15% until 24 October 2024.

行政開支及其他開支

本集團的行政開支及其他開支自截至二零 二一年十二月三十一日止年度的約人民幣 52,900,000元減少約24.8%至截至二零 二二年十二月三十一日止年度的約人民幣 39,800,000元。減少主要是由於並無於截 至二零二二年十二月三十一日止年度確認 無形資產攤銷(截至二零二一年止年度: 人民幣12,400,000元)所致。

財務成本

截至二零二二年十二月三十一日止年度, 本集團的財務成本(包括銀行貸款及承兑 票據)約為人民幣54,100,000元(二零二 一年:人民幣28,100,000元)。有關增加 主要是由於延長承兑票據的利息開支所 致。截至二零二一年及二零二二年十二月 三十一日止年度,銀行貸款利率為介乎最 優惠利率減2%或一個月銀行同業拆息加 3%(以較低者為準)至年利率7%的浮動利 率。

税項

本公司的中國附屬公司從事互聯網線上教 育服務供應商,成功具備中國高新技術企 業項目資格,並已於二零一七年取得中國 高新技術企業認證。因此,該附屬公司須 按15%的税率繳納中國企業所得税(「企業 所得税」),直至二零二四年十月二十四日 止。

Profit/(Loss) for the Year

As a result of the challenging conditions, the Group's profit for the year ended 31 December 2022 was approximately RMB10.8 million, compared to Group's loss of approximately RMB255.9 million for the previous year. The reason of the profit is mainly due to the impairment loss of intangible assets of internet education services business of nil (for the year ended 2021: RMB52.8 million) and the impairment loss of goodwill of eCommerce business and internet education services business of nil (for the year ended 2021: RMB212.4 million). Earning per share attributable to the owners of the Company was approximately RMB0.26 cents for the year ended 31 December 2022, as compared to loss per share attributable to the owners of the Company of approximately RMB6.49 cents for the year ended 31 December 2021.

Final Dividends

The Board does not recommend the payment of a final dividend for year ended 31 December 2022 (2021: Nil).

Capital Structure, Liquidity and Financial Resources

As at 31 December 2022, the Group's bank balances and cash was approximately RMB44.2 million (2021: RMB44.6 million).

Total equity of the Group as at 31 December 2022 was approximately RMB141.8 million (2021: RMB53.8 million). The Group has an outstanding promissory notes of approximately RMB159.3 million as at 31 December 2022 (2021: RMB242.8 million, respectively).

Material Acquisitions and Disposals of Subsidiaries and Associated Companies

Material Disposal of Subsidiary and Investment

During the reporting period, the Group had no other material acquisitions or disposal.

Pledge of Assets

As at 31 December 2022, the Group has pledged buildings with carrying values of approximately RMB7,288,000 to secure the promissory notes of the Group (2021: Nil). Gearing ratio is calculated based on total debt at the end of the year divided by total assets at the end of the year multiplied by 100%. As at 31 December 2022, the gearing ratio of the Group was 47% (2021: 69%).

Currency Exchange Exposures

The Group's purchases and sales are mainly denominated in US dollars, Renminbi and Hong Kong dollars. The operating expenses of the Group are mainly in Hong Kong dollars and Renminbi. The Group has well monitored and managed its exposure to fluctuation in currency exchange rates.

CONTINGENT LIABILITIES

As at 31 December 2022, saved as disclosed above and in this report, the Group had not provided any form of guarantee to any company outside of the Group and is not involved in any current material legal proceedings, nor is the Group aware of any pending or potential material legal proceedings involving the Group.

PROMISSORY NOTES

On 9 November 2015, the Company issued promissory notes for an aggregate principal amount of HK\$213.6 million at 2% interest per annum (the "PN1") upon completion of the acquisition of Soaring International Holdings Limited to Mr. Lee Yim ("Mr. Lee") and Mr. Ng Hang Fai Calvin ("Mr. Ng") (the "Vendors"), independent third parties not connected to the Group. The PN1 are due on the third anniversary of the date of issue. On 2 November 2018, the Vendors and the Company have agreed to extend the maturity of the PN1 to 9 November 2020.

On 9 July 2019, the Company entered into the deed of amendment with the Vendors to extend the maturity date of the PN1 to 9 July 2021 and decrease the interest rate from 2% to 1% per annum effective from 9 July 2019.

On 2 December 2020, the Company entered into the deed of amendment with the Vendors to extend the maturity date of the PN1 to 1 April 2022 and the interest rate remained to 1% per annum effective from 2 December 2020. The effective interest rate of PN1 is 9.89%.

The fair value of PN1 was approximately to their principal amount calculated at the effective interest rate of 7.89% per annum. The PN1 is classified as non-current liabilities and are carried at amortised cost until settlement on due date.

From year 2018 to 2020, the Company issued four promissory notes of each principal amount of HK\$55,000,000 (the "PN2", "PN3", "PN4", "PN5"), non-interest bearing, upon fulfillment of profit guarantee by Cybernaut Technology International Limited and its subsidiaries ("CTIL"). The PN2 to PN5 will be maturity on the second anniversary of the date of issue. The effective interest rate of the PN2, PN3, PN4 and PN5 are 13.36%, 9.78%, 9.78% and 15.36% respectively.

During the year ended 31 December 2020, PN2 to PN5 was transferred/assigned to Win All Management Limited ("Win All") & Wide Select Investments Limited ("Wide Select") which are wholly-owned by the Vendors, on 25 September 2020 and 4 December 2020, the maturity date of PN2 to PN4 were extended to 1 April 2022 and the interest rate amended to 1% from 4 December 2020.

於二零一九年七月九日,本公司與賣方訂 立修訂契據,將PN1之到期日延長至二零 二一年七月九日,並自二零一九年七月九 日起將年利率由2%減至1%。

於二零二零年十二月二日,本公司與賣方 訂立修訂契據,將PN1之到期日延長至二 零二二年四月一日,並自二零二零年十二 月二日起將年利率維持於1%水平。PN1 的實際利率為9.89%。

PN1的公平值約相等於其本金額,乃按 7.89%的實際年利率計算。PN1乃分類為 非流動負債及直至於到期日清償前按攤銷 成本列賬。

於二零一八年至二零二零年,本公司 於Cybernaut Technology International Limited及其附屬公司(「CTIL」)達成溢 利保證後發行四份不計息承兑票據,每 份本金額為55,000,000港元(「PN2」、 「PN3」、「PN4」、「PN5」)。PN2至PN5 將於發行日期起計兩年到期。PN2、 PN3、PN4及PN5之實際利率分別為 13.36%、9.78%、9.78%及15.36%。

截至二零二零年十二月三十一日止年度, PN2至PN5已於二零二零年九月二十五 日及二零二零年十二月四日轉讓/出讓 予賣方全資擁有的Win All Management Limited(「Win」)及Wide Select Investments Limited(「Wide Select」), PN2至PN4的到期日延長至二零二二年四 月一日,而利率自二零二零年十二月四日 起修訂為1%。



On 30 June 2021, all the holders of promissory notes (the "PN holders") agreed to extend the maturity date of PN1 to PN5 to 31 March 2023 as well. And the interest rate of PN5 was then changed to 1% per annum with effective from 30 June 2021.

During the year 2021, the PN holders had partly redeemed the principal amount of PN1 and the remaining aggregate principal amounts of PN1 was HK\$171,416,000.

On 31 December 2021, the Company and PN holders entered in to deed of amendment to reorganise and assign all the promissory notes of the Group with the principal and interest amounting to approximately HK\$368,902,000 (approximately to RMB301,644,000) and HK\$9,663,000 (approximately to RMB8,102,000) in total respectively to two new holders of two new promissory notes namely New PN1 and New PN2 with principal amounting to HK\$208,208,000 (approximately to RMB172,798,000) and HK\$183,208,000 (approximately to RMB152,050,000) respectively. The management of the Group considers that the terms of the deed of amendment are substantially different as the discounted present value of the cash flows under the new terms discounted using the original effective interest rate is different from the discounted present value of the remaining cash flows of the original financial liability by more than 10 per cent. Accordingly, such modification of terms is accounted for as an extinguishment of the original financial liability and the recognition of a new financial liability. Therefore, the Group derecognised the original promissory notes outstanding and recognised the two new promissory notes measured at fair value as at the date of extinguishment. The difference between the carrying amount of the promissory notes derecognised and the fair value of the New PN1 and New PN2 amounting to approximately HK\$80,696,000 (approximately to RMB66,973,000) is recognised in profit or loss during the year ended 31 December 2021.

於二零二一年六月三十日,所有承兑票 據持有人(「PN持有人」)亦同意將PN1至 PN5的到期日延長至二零二三年三月三十 一日。而PN5的年利率隨後改為1%,自 二零二一年六月三十日起生效。

於二零二一年,PN持有人已贖回部分 PN1之本金額,而PN1之餘下本金總額為 171,416,000港元。

於二零二一年十二月三十一日,本公司 與PN持有人訂立修訂契據,以重組及轉 讓本集團所有承兑票據,本金及利息總 額分別約為368,902,000港元(約人民幣 301,644,000元)及9,663,000港元(約人 民幣8,102,000元),予兩份新承兑票據 (即新PN1及新PN2)的兩名新持有人,本 金額分別為208,208,000港元(約人民幣 172,798,000元)及183,208,000港元(約 人民幣152,050,000元)。本集團管理層 認為,修訂契據之條款有重大差異,原因 為使用原實際利率貼現之新條款項下現金 流量之貼現現值與原金融負債餘下現金流 量之貼現現值相差超過百分之十。因此, 有關條款修訂入賬列為取消原金融負債及 確認新金融負債。因此,本集團終止確認 尚未償還之原承兑票據,並確認兩份於清 償日期按公平值計量之新承兑票據。已終 止確認之承兑票據的賬面值與新PN1及新 PN2的公平值之間的差額約80,696,000港 元(約人民幣66,973,000元)於截至二零 二一年十二月三十一日止年度的損益中確 認。



In addition, all nominal interest of promissory notes are waived from 9 November 2019 to 31 December 2021.

The fair value of PN 1 and PN2 approximately to their principal amount calculated at the effective interest of 15.68% per annum. The PN 1 and PN 2 are both classified as non-current liabilities and are carried at amortised cost until settlement on due date.

On 27 May 2022, the Company entered into a subscription agreement with PN1 holder for the subscription of convertible preference shares of the Company at the total subscription price of HK\$140,000,000 (approximately to RMB116,206,000) which was satisfied by the set-off of part of the principal owned to PN 1.

On 31 December 2022, the Company entered a deed of amendment with all PN holders to extend the maturity dates of the PN 1 and PN 2 and to amend certain terms and conditions of those PNs. The management of the Group considers that the terms of the deed of amendment are substantially different as the discounted present value of the cash flows under the new terms discounted using the original effective interest rate is different from the discounted present value of the remaining cash flows of the original financial liability by more than 10 per cent. Accordingly, such modification of terms is accounted for as an extinguishment of the original financial liability and the recognition of a new financial liability. Therefore, the Group derecognised the original promissory notes outstanding and recognised the two new promissory notes measured at fair value as at the date of extinguishment. The difference between the carrying amount of the promissory notes derecognised and the fair value of the PN1 and PN2 amounting to approximately HK\$42,846,000 (approximately to RMB51,699,000) is recognised in profit or loss during the year ended 31 December 2022 (for details, please refer to Note 33 to the financial statements in this annual report).

於二零二二年十二月三十一日,本公司與 所有承兑票據持有人訂立修訂契據,以延 長PN1及PN2之到期日,並修訂該等承兑 票據之若干條款及條件。本集團管理層認 為,修訂契據之條款有重大差異,原因為 使用原實際利率貼現之新條款項下現金流 量之貼現現值與原金融負債餘下現金流量 之貼現現值相差超過百分之十。因此,有 關條款修訂入賬列為取消原金融負債及確 認新金融負債。因此,本集團終止確認尚 未償還之原承兑票據,並確認兩份於取消 當日按公平值計量之新承兑票據。已終止 確認之承兑票據的賬面值與PN1及PN2的 公平值之間的差額約42,846,000港元(約 人民幣51,699,000元)於截至二零二二年 十二月三十一日止年度的損益中確認(有 關詳情請參閱本年報財務報表附註33)。



CONVERTIBLE PREFERENCE SHARES

On 27 May 2022, the Company entered into the Subscription Agreement with the Subscriber (Wide Select Investments Limited), pursuant to which the Company has conditionally agreed to allot and issue, and the Subscriber has conditionally agreed to subscribe for, 933,333,000 Convertible Preference Shares for an aggregated Consideration of HK\$140,000,000, representing the Subscription Price of approximately HK\$0.15 per Convertible Preference Share. The aggregated Subscription Price shall be satisfied in full by setting off against the Company's obligation to repay part of the Promissory Note in the amount of HK\$140,000,000. The Conversion Price at which Conversion Shares will be issued upon exercise of the Conversion Right attaching to the Convertible Preference Shares is the Subscription Price, i.e. approximately HK\$0.15, subject to adjustments. For the avoidance of doubt, the Subscriber is not required to pay any additional money upon conversion of the Convertible Preference Share(s) to Ordinary Share(s), other than taxes and stamp, issue and registration duties (if any) arising on conversion. No application will be made for the listing of, or permission to deal in, the Convertible Preference Shares on the Stock Exchange or any other stock exchange. The Company has applied to the Stock Exchange for the listing of, or permission to deal in, the Conversion Shares. The convertible preference shares are non-voting shares and non-redeemable. The holders of the preference shares are entitled to receive the same dividends as the holders of ordinary shares. In addition, the holders of the preference shares have the right to convert any preference share into the Company's ordinary shares at any time at the conversion price at the rate of 1 to 1 each. The conversion price will be subject to adjustments only upon occurrence of certain dilutive events.

CONTRACTUAL AGREEMENTS

During the year ended 31 December 2017, certain business activities of the Group which were/are categorised as "restricted" business under the PRC laws and regulations have been carried out by the Group through a series of contractual arrangements (the "VIE Agreements"), and that happened at the acquisition of Cybernaut Technology International Limited (the "Project Company") on 22 November 2017. The VIE agreements are a series of agreements, including but not limited to the Management Services Agreement, the Equity Pledge Agreement, the Loan Agreement, the Irrevocable Option Agreement, the Power of Attorney, the Undertaking Letters and the Declaration Letters, executed for the purpose of establishing the variable interest entity arrangement between Huzhou Company and Wowxue, through which the financial results of Wowxue are consolidated with the financial results of Huzhou Company as "variable interest entity" (as defined in Hong Kong and International Financial Reporting Standards). The VIE business and VIE Agreements are disclosed in the circular dated 27 October 2017 and as below.

REASON FOR ENTERING INTO THE VIE AGREEMENTS

Investing in the PRC by foreign investors is primarily regulated by "外商投資產業指導目錄 (2017年修訂) (the Guidance Catalogue of Industries for Foreign Investment (2017 Revision)*)" (the "Catalogue"), which was promulgated and is amended from time to time jointly by the Ministry of Commerce of the PRC and the National Development and Reform Commission. Pursuant to the Catalogue, the value-added telecommunication services related business of Wowxue is considered as "restricted" under the categories of value-added telecommunication services. Therefore, foreign investors can only operate valueadded telecommunication business in the PRC under joint ventures with the foreign portion of the total investment and hence shareholding below 50%. As Hong Kong Cybernaut, the subsidiary of the Target Company, is the foreign investor of Huzhou Company, it is not allowed to indirectly hold more than 50% equity interest in Wowxue through Huzhou Company or directly hold more than 50% equity interest in Wowxue under the PRC laws.

截至二零一七年十二月三十一日止年度, 本集團透過一系列合約安排(「可變利益 實體協議」)從事本集團根據中國法律及 法規分類為「受限制」業務的若干業務活 動,並於二零一七年十一月二十二日收 購Cybernaut Technology International Limited (「項目公司」)時進行。可變利益 實體協議為湖州公司與沃學就確定可變利 益實體安排而簽立的一系列協議(包括但 不限於管理服務合同、股權質押協議、貸 款協議、不可撤回的購股權協議、授權委 托書、承諾函以及聲明函),據此,沃學 之財務業績綜合入賬至湖州公司財務業績 作為「可變利益實體」(定義見香港及國際 財務報告準則)。可變利益實體業務及可 變利益實體協議披露於日期為二零一七年 十月二十七日的通函並載列如下。

訂立可變利益實體協議之理由

外國投資者於中國的投資活動主要受《外 商投資產業指導目錄(二零一七年修訂)》 (「目錄」)所規管,該目錄由中國商務部 及國家發展和改革委員會共同頒佈及不時 修訂。根據目錄,沃學之增值電信服務 關業務被視為增值電信服務類別下的「受 限制」業務。因此,外國投資者僅可透過 外商投資總額及股權低於50%的合資企業 於中國經營增值電信業務。由於目標公司 之附屬公司香港賽伯樂為湖州公司之外國 投資者,故根據中國法律其不得透過湖州 公司間接持有沃學超過50%股權。

In light of the above, Huzhou Company, Wowxue and the Registered Shareholders have entered into the VIE Agreements on 31 August 2017 (as amended by supplemental agreements dated 25 September 2017) for the Reorganisation in order to enable the financial results, the entire economic benefits and the risks of the businesses of Wowxue to flow into Huzhou Company and to enable the Project Company to have indirect control over Wowxue as contemplated under the Sale and Purchase Agreement.

The Company agrees that it would unwind the VIE Agreements as soon as the relevant laws and regulations allow the valueadded telecommunications business in the PRC to be operated by foreign investors without adopting a VIE structure. However, it is uncertain at this stage when the restrictions on foreign ownership in value-added telecommunications businesses will be lifted in the PRC. Under the Irrevocable Option Agreement, the Registered Shareholders must return to Huzhou Company or its nominee any consideration the Registered Shareholders had received from Huzhou Company for the acquisition of the equity interest in Wowxue.

Up to 31 December 2022 of this report and 28 March 2023 for approval of the audited annual financial results, the Group has not encountered any interference or encumbrance from any governing bodies since the suspension of the Wowxue business.

The PRC Legal Adviser has confirmed, among others, that (i) the use of the VIE structure and the VIE Agreements do not violate the relevant prevailing laws and regulations in the PRC; (ii) the VIE Agreements would not be deemed as concealing illegal intentions with a lawful form and void under the PRC contract law; and (iii) save for the clause providing that the arbitration tribunal may award injunctive relief or winding up orders and that the courts in Hong Kong, the Cayman Islands and the PRC may grant temporary injunctive relief or other temporary remedies, which may not be enforceable under PRC law, the VIE Agreements are enforceable under the laws of the PRC. Based on the above, the Directors believe that the VIE Agreements conferring significant control and economic benefits from Wowxue to the Target Company are enforceable under the relevant laws and regulations.

本公司同意,當相關法律及法規容許外國 投資者不透過採用可變利益實體架構於中 國開展增值電信業務,即會盡快解除可變 利益實體協議。然而,現階段增值電信業 務外商擁有權限制何時於中國解除仍屬未 知之數。根據不可撤回的購股權協議,登 記股東須退還因湖州公司收購沃學股權而 收取之任何代價予湖州公司或其提名人。

截至本報告日期(二零二二年十二月三十 一日)及批准經審核全年財務業績日期 (二零二三年三月二十八日),本集團自沃 學業務的暫停起並無遭遇任何來自規管機 構之干涉或妨礙。



Protection of the interest and assets of Wowxue

The Management Services Agreement, Irrevocable Option Agreement, Loan Agreement, Equity Pledge Agreement, and the Undertaking Letters include a provision that each agreement is binding on the successors and permitted assignees of the respective parties. In the event of death, bankruptcy or divorce of any party of the Registered Shareholders, Huzhou Company may exercise its option under the Irrevocable Option Agreement to replace the relevant party of the Registered Shareholders, thus protecting the interest of the Group and allowing Huzhou Company to enforce its rights under the VIE Agreements against the successors and permitted assignees of the shareholders of Wowxue.

In order to have effective control over and to safeguard the assets of Wowxue, the VIE Agreements provide that, without the prior written consent of Huzhou Company, Wowxue shall not, in any form, dispose of significant assets (including but not limited to any significant customer resources, fixed assets, trademarks, technical knowhow or other intellectual property rights and/ or other equity interests or similar interests held by Wowxue), operating rights and/or dispose of all or part of its business (including sale, replacement, mortgage or disposal in any other ways), with respect to it and/or its subsidiaries (if any).

The VIE Agreements also provide that, without the prior written consent of Huzhou Company, (i) Wowxue shall not increase or decrease the registered capital or accept any investment or capital increase from the Registered Shareholders or any third parties to Wowxue or change the form of the company or make any major adjustments regarding carrying out liquidation or dissolution; or the business scope, mode, profit model, marketing strategy, business policy or customer relationship; (ii) Wowxue and/or its subsidiaries shall not enter into any partnership or joint venture or profit sharing arrangement with any third parties, or any other arrangements for the transfer of benefits or profit sharing in the form of royalties, service fees or consultancy fees; and (iii) Wowxue shall not declare or distribute dividends or any other interests to its shareholders, including the after-tax profits that Wowxue has not yet allocated before the commencement of the VIE Agreements.

可變利益實體協議亦規定,未經湖州公司 事先書面同意,(i)沃學不得增加或減少註 冊資本,或允許登記股東或任何第三方向 沃學增加任何投資或資本,或更改公司形 式或作出任何有關進行清算或解散的重大 調整;或對業務範圍、模式、盈利模式、 營銷調整;(ii)沃學及/或其附屬公司不得 與分安排,或以特許權使用費、服務費或 顧問費形式轉讓利益或攤分溢利的任何其 做安排;及(iii)沃學不得向其股東宣派或變 利益實體協議前尚未分配之除税後溢利。

Since the completion to acquire the Project Company on 22 November 2017, there were no changes in the VIE structure up to 31 December 2021. The Board has reviewed the VIE structure regularly and determined if the Group encounters any issues in safeguarding its assets held through the VIE Agreements. If any major issues or difficulties arise in doing so, the Board will engage legal advisers and/or other professionals to assist the Group to tackle such issues or difficulties.

Financial information of Wowxue

Under the VIE Agreements, Wowxue is accounted for as a consolidated structured entity that as a subsidiary of the Group. For the year ended 31 December 2021, Wowxue recognised total revenue of nil; loss of RMB2,281,000 and Total assets of RMB52,427,000.

VIE Agreements confer economic benefits on Huzhou Company from Wowxue

The VIE Agreements confer upon the Group the right to enjoy all the economic benefit of Wowxue by the Management Services Agreement under which Wowxue will pay Huzhou Company the management and consultancy fees equivalent to the total income of Wowxue minus all relevant costs, expenses and taxes payable by Wowxue. 自於二零一七年十一月二十二日完成收購 項目公司後,截至二零二一年十二月三十 一日止,可變利益實體架構並無變動。董 事會定期審查可變利益實體架構,並確定 本集團在透過可變利益實體協議保護其資 產方面是否遇到任何問題。倘出現任何重 大問題或困難,董事會將聘請法律顧問 及/或其他專業人士協助本集團處理相關 問題或困難。

可變利益實體協議向湖州公司賦予沃學之 經濟利益

可變利益實體協議透過管理服務合同賦予 本集團享有沃學所有經濟利益之權利,據 此,沃學將向湖州公司支付管理及顧問 費,費用相等於沃學之總收入減去沃學應 付之所有相關成本、開支及税項。



VIE Agreements confer control from Wowxue to Huzhou Company

The VIE Agreements confer upon the Group sufficient control over the board and daily operations of Wowxue. The appointment of directors of Wowxue is subject to Huzhou Company being satisfied of the director's qualification and requires the explicit consent of Huzhou Company. If Huzhou Company is dissatisfied with the performance of the director(s) of Wowxue and proposes to remove such director(s), Wowxue shall remove such person(s) as director(s) upon Huzhou Company's proposal. Also, Wowxue agreed with Huzhou Company that Wowxue will, and its shareholders will cause Wowxue to, accept proposals put forward by Huzhou Company relating to the daily operations of Wowxue and employment of staff, operate all business of Wowxue in the ordinary course of business and refrain from any action or omission that may adversely affect the business of Wowxue.

Moreover, under the Management Services Agreement, Huzhou Company will formulate rules, regulations, internal control policies, risk control management systems, standards administration, accounting, budget, marketing, human resources and operating policies, as well as the practices which are relevant to or affecting the business of Wowxue, and assist Wowxue in the effective implementation of relevant policies and practices.

Furthermore, as a general housekeeping rule, Huzhou Company will have the custody of the constitutional items of Wowxue, including the company chop and seal. At the request of Huzhou Company, Wowxue will provide it with the relevant legal documents and other information on Wowxue's business operation.

可變利益實體協議向湖州公司賦予沃學之 控制權

可變利益實體協議向本集團授予沃學董事 會及日常經營的充分控制權。沃學董事的 委任須受湖州公司信納董事資歷規限及湖 州公司的明確同意。倘湖州公司不滿意沃 學董事的表現並建議罷免有關董事,沃學 須於湖州公司提出建議後罷免有關人士的 董事職務。同時,沃學向湖州公司表示同 意,沃學及其股東將促使沃學接受湖州公 司就沃學日常運營及僱用員工提出的建 議、於日常業務過程中營運沃學的所有業 務以及避免任何可能對沃學業務造成不利 影響的行為或遺漏。

此外,根據管理服務合同,湖州公司將制 定規則、規例、內部控制政策、風險控制 管理制度、標準管理條例、會計、預算、 營銷、人力資源及營運政策,以及與沃學 業務有關或對其產生影響的慣例,且將協 助沃學有效落實相關政策及慣例。

再者,作為一般管理規定,湖州公司將有 權保管沃學的章程用品,包括公司印鑑及 印章。沃學將應湖州公司要求向其提供沃 學業務營運的相關法律文件及其他資料。



RISKS AND LIMITATIONS RELATING TO THE VIE AGREEMENTS

1. Economic risks of the Company

Huzhou Company, as the primary beneficiary of Wowxue, is not obligated under any of the VIE Agreements to share the losses of Wowxue or provide financial support to Wowxue. Moreover, as a limited liability company, Wowxue is solely liable for its own debts and losses. As advised by the PRC Legal Adviser, the PRC laws and regulations do not expressly require Huzhou Company to share the losses of Wowxue or provide financial support to Wowxue.

2. Limitations in exercising the option to acquire ownership in Wowxue

In the case that Huzhou Company exercises its options to acquire all or part of the equity interest in Wowxue under the Irrevocable Option Agreement, the acquisition of the entire equity interests in Wowxue may only be conducted to the extent as permitted by the applicable PRC laws and may be subject to necessary approvals and relevant procedures under applicable PRC laws.

Further, a substantial amount of other costs (if any), expenses and time may be involved in transferring the ownership of Wowxue, which may have a material adverse impact on Huzhou Company's businesses, prospects and results of operation.

Huzhou Company may need to pay a substantial amount of enterprise income tax for the income from the ownership transfer according to the Irrevocable Option Agreement.

有關可變利益實體協議的風險及 限制

> 根據任何可變利益實體協議,作為 沃學的主要受益人,湖州公司無義 務分擔沃學的虧損或向沃學提供財 務支持。此外,作為一家有限公 司,沃學對其自身債務及虧損全權 負責。經中國法律顧問告知,中國 法律法規並未明確規定湖州公司須 分擔沃學的虧損或向沃學提供財務 支持。

行使購股權以收購沃學擁有權的限制 2.

倘湖州公司根據不可撤回的購股權 協議行使其購股權以收購沃學的全 部或部分股權,收購沃學全部股權 僅可在適用中國法律准許的情況下 進行,且或須根據適用中國法律規 定獲得必要的批准及經由相關程序。

此外,轉讓沃學擁有權時或會涉及 較大數額的其他費用(如有)、開支 及時間,可能對湖州公司的業務、 前景及經營業績產生重大不利影響。

根據不可撤回的購股權協議,湖州 公司或需就來自擁有權轉讓的收入 繳納巨額企業所得税。



3. Arrangements when potential conflicts of interest arise

Huzhou Company shall rely on the VIE Agreements to exercise control over and to draw the economic benefits from Wowxue. Huzhou Company may not be able to provide sufficient incentives to the Registered Shareholders for the purpose of encouraging it/them to act in the best interests of Wowxue, other than stipulating the relevant obligations in the VIE Agreements. The Registered Shareholders may breach the VIE Agreements in the event of conflicts of interest or deterioration of its/ their relationship with Huzhou Company, the results of which may have a material adverse impact on Huzhou Company's business, prospects and results of operation.

It is not assured that if conflicts arise, the Registered Shareholders will act in the best interests of Huzhou Company or that the conflicts will be resolved in favour of Huzhou Company. If any of the Registered Shareholders fail to perform its obligations under the respective VIE Agreements, Huzhou Company may have to rely on legal remedies under the PRC laws through legal proceedings, which may be expensive, time-consuming and disruptive to Huzhou Company's operations and will be subject to uncertainties as discussed above.

4. Other risks relating to the VIE Agreements

Firstly, despite (i) there is currently no indication that the VIE Agreements will be interfered or objected by any PRC regulatory authorities; and (ii) the PRC Legal Adviser is of the view that the VIE Agreements do not violate any prevailing PRC laws or regulations, uncertainties still exist regarding the interpretation and application of the PRC laws and regulations especially in the area of value-added telecommunications business. For instance, the PRC regulatory authorities may issue further guidelines that impose stricter foreign ownership requirements in that area of business. Given the uncertain legal and business environment in the PRC, it is difficult to foresee whether the PRC regulatory authorities will take the same view regarding the VIE Agreements as the PRC Legal Adviser in the future.

3. 出現潛在利益衝突時之安排

湖州公司將倚賴可變利益實體協議 行使控制權及自沃學抽取經濟利 益。除於可變利益實體協議訂明者 關責任外,湖州公司可能無法就 勵登記股東以沃學之最佳利益行 助東可能於出現利益看突 調州公司之關係惡化時違反可 與湖州公司之關係惡化時違反可 制益 實體協議,其結果可能對湖州 公司之業務、前景及經營業績產生 重大不利影響。

概不保證當發生衝突時,登記股東 將以湖州公司之最佳利益行事或解 突將以對湖州公司有利之方式解 決。倘任何登記股東未能履行其於 各可變利益實體協議項下之責任, 湖州公司可能須透過法律訴訟依賴 中國法律下之法律補救,此可能屬 昂貴、耗時及中斷湖州公司之營 運,且可能面臨上文所討論之不明 朗因素。

4. 有關可變利益實體協議的其他風險



On 19 January 2015, the Ministry of Commerce of the PRC published the draft PRC Foreign Investment Law (中華人民共和國外國投資法(草案徵求意見稿)) and the Explanation on the draft PRC Foreign Investment Law (關 於《中華人民共和國外國投資法(草案徵求意見稿)》的說 明) (collectively the "Draft Law") pursuant to which foreign companies gaining control over domestic companies via contractual arrangements such as the VIE Agreements will be regarded as foreign investments and will be governed by the Draft Law when it is adopted and becomes law. The PRC Legal Adviser is of the view that the Draft Law is currently in consultation stage and has not yet been effective or legally binding. As there are uncertainties on the final content and interpretations of the Draft Law, there is no assurance that the VIE Agreements will comply with the Draft Law when it is adopted and becomes law.

Secondly, the VIE Agreements may not provide control as effective as direct ownership. Huzhou Company does not have any direct equity ownership in Wowxue and has relied on the VIE Agreements to effect changes in the management of Wowxue and make an impact on its business decision making, as opposed to exercising its rights directly as a shareholder. If Wowxue or its shareholders refuse to cooperate, the Company will face difficulties in effecting control over Wowxue's operation of business through the VIE structure, which may adversely affect the Company's business efficiency. 於二零一五年一月十九日,中國商 務部頒佈《中華人民共和國外國投資 法(草案徵求意見稿)》及關於《中 華人民共和國外國投資法(草案徵 求意見稿)》的説明(統稱「法律草 案」),據此,透過合約安排(如可變 利益實體協議) 取得內資公司控制權 之外資公司將被視為外國投資,並 將於法律草案獲採納及成為法律時 受其規管。中國法律顧問認為,法 律草案現時僅供諮詢用途,尚未生 效或具有法律約束力。由於法律草 案之最終內容及詮釋存在不確定因 素,故無法保證可變利益實體協議 將符合法律草案(倘其獲採納及成為 法律)。

第二,可變利益實體協議賦予的控 制權未必如直接擁有同樣有效。湖 州公司並未直接擁有任何沃學股 權,且倚賴可變利益實體協議以對 沃學管理層實施變動及對其業務 策作出影響,而非作為股東直接行 使其權利。倘沃學或其股東拒絕合 作,本公司將難以透過可變利益實 體架構對沃學的業務營運實施控制 權,從而對本公司的業務效益造成 不利影響。



Thirdly, according to the Regulations on the Administration of Foreign-invested Telecommunication Enterprises (2016 Revision) (外商投資電信企業管理規定 (2016 修 訂)) (the "FITE Regulations"), which were promulgated by the State Council of the PRC on 11 December 2001, and amended on 10 September 2008 and 6 February 2016, it requires a foreign investor who invests in a value-added telecommunications business in the PRC must possess prior experience in operating value-added telecommunications businesses and a proven track record of business operations overseas (the "Qualification Requirement"). Currently, none of the applicable PRC laws, regulations or rules provides clear guidance or interpretation on the Qualification Requirement. Despite the lack of clear guidance or interpretation on the Qualification Requirements, the Company intends to acquire the entire equity interests in the Wowxue when the PRC laws allow foreign investors to invest in valueadded telecommunications business in the PRC. The Group plans to take steps to build up its track record of overseas value-added telecommunications business operations in an attempt to comply with the Qualifications Requirements, i.e., to establish overseas office in Hong Kong and to register a certain number of domain names outside of the PRC for conducting operation of websites and other businesses in relation to value-added telecommunication services in Hong Kong in coming years, so as to be qualified to acquire the entire equity interests in the Wowxue when the relevant PRC laws allow foreign investors to invest and to hold a majority interest in value-added telecommunications enterprises in PRC. However, there is a risk that when the restrictions on foreign ownership in value-added telecommunications businesses are lifted in the PRC, Huzhou Company may still be required to unwind the VIE Agreements before Huzhou Company's foreign investor Hong Kong Cybernaut is in a position to fully comply with the Qualification Requirement. Therefore, there is no guarantee that the steps taken will be sufficient to enable Huzhou Company to ultimately acquire the ownership in Wowxue.

第三,根據中國國務院於二零零一 年十二月十一日頒佈且於二零零八 年九月十日及二零一六年二月六日 修訂的《外商投資電信企業管理規 定(二零一六年修訂)》(「《外商投資 電信企業管理規定》」),投資中國增 值電信業務的外國投資者必須擁有 經營增值電信業務的經驗,且海外 營業過往記錄良好(「資質規定」)。 目前,概無適用中國法律、法規或 規則就資質規定作出明確指引或詮 釋。儘管資質規定欠缺清晰指引或 詮釋,本公司擬於中國法律允許外 國投資者在中國投資增值電信業務 時收購沃學之全部股權。本集團計 劃採取措施建立海外增值電信業務 經營之往績記錄,力圖符合資質規 定,即於未來數年就香港增值電信 服務在香港設立海外辦事處及在 中國境外註冊多個域名,以經營網 站及開展其他業務,從而於相關中 國法律允許外國投資者在中國投資 增值電信企業及持有其大部分權益 時合資格收購沃學之全部股權。然 而,倘中國就增值電信業務的外資 擁有權撤銷限制,湖州公司可能仍 須解除可變利益實體協議,湖州公 司的外國投資者香港賽伯樂方可完 全符合資質規定。因此,概不保證 所採取的措施足以令湖州公司最終 獲得沃學的擁有權。



Fourthly, the VIE Agreements may be subject to scrutiny by the tax authorities and additional tax may be imposed. Under the Management Services Agreement, Wowxue is required to pay Huzhou Company management and consultancy fees for the services rendered by Huzhou Company. Such service fee payments between related parties may be subject to scrutiny or challenge by the PRC tax authorities within ten years after the taxable year when such transactions are conducted.

Fifthly, the VIE Agreements are governed by the PRC laws. When a dispute arises under any of the VIE Agreements, the parties to the dispute may have to rely on legal remedies under the PRC laws. The VIE Agreements provide that dispute will be submitted to the South China International Economic and Trade Arbitration Commission (華南國際經濟貿易仲裁委員會) for arbitration to be conducted in Shenzhen. The decision of such arbitration is final and binding on the parties to the dispute.

Since the legal environment in the PRC is different from that in Hong Kong and other jurisdictions, the uncertainties in the PRC legal system could limit the ability of Huzhou Company to enforce the VIE Agreements. There is no assurance that such arbitration result will be in favour of Huzhou Company and/or that there will not be any difficulties in enforcing any arbitral awards granted, including specific performance or injunctive relief and claiming damages by Huzhou Company. As Huzhou Company may not be able to obtain sufficient remedies in a timely manner, its ability to exert effective control over Wowxue and the conduct of the valueadded telecommunication business could be materially and adversely affected, and may disrupt the business of Huzhou Company and have a material adverse impact on Huzhou Company's business, prospects and results of operation.

第四,可變利益實體協議或會受税 務機構的審查及可能被徵收額外税 項。根據管理服務合同,沃學須就 湖州公司提供的服務向其支付管理 及諮詢費。關連方之間的相關服務 費款項或會於相關交易進行的税務 年度後十年內受到中國税務機構的 審查或質疑。

第五,可變利益實體協議受中國法 律規管。倘任何可變利益實體協議 出現爭議,爭議各方可能須倚賴中 國法律項下的法律補救措施。可變 利益實體協議規定,爭議將提呈 予華南國際經濟貿易仲裁委員會, 以於深圳進行仲裁。就爭議各方而 言,相關仲裁決定屬最終且具約束 力。



Lastly, the VIE Agreements provide that the arbitration tribunal may award remedies over the equity interests or assets of Wowxue or injunctive relief (e.g. for the conduct of business or to compel the transfer of assets) or order the winding up of Wowxue. The VIE Agreements also include a clause in relation to dispute resolution among the parties where, when awaiting the formation of the arbitration tribunal or otherwise under appropriate conditions, the parties thereto may seek temporary injunctive relief or other temporary remedies from the courts in Hong Kong, Cayman Islands, the PRC and the location where the principal assets of the Company and Wowxue are located.

However, the PRC Legal Adviser is of the view that pursuant to the PRC laws, the arbitration tribunal may have no power to grant the aforementioned remedies or injunctive relief or to order the winding up of Wowxue. In addition, even though the VIE Agreements provide that overseas courts (e.g. courts in Hong Kong and Cayman Islands) shall have the power to grant certain relief or remedies, such relief or remedies may not be recognised or enforced under the PRC laws. As a result, in the event that Wowxue or the Registered Shareholders breaches the terms of the VIE Agreements, the Company may not be able to obtain sufficient remedies in a timely manner, and its ability to exert effective control over Wowxue could be materially and adversely affected. Huzhou Company does not maintain any insurance to cover the risks relating to the VIE Agreements.

The Board will continue to review the VIE Structure regularly and determine if the Group encounters any issues in safeguarding its assets held through the VIE Agreements. If any major issues or difficulties arise in doing so, the Board will continue to engage legal advisers and/or other professionals to assist the Group to tackle such issues or difficulties. Up to 31 December 2021, the Group does not maintain any insurance to cover the risks relating to the VIE Agreements. 最後,可變利益實體協議規定,仲 裁庭可就沃學之股權或資產頒佈補 救措施或禁令濟助(如就經營業務或 強制轉讓資產)或頒令沃學清盤。可 變利益實體協議亦載有解決訂約方 之間爭議之條文,據此,當等候仲 裁庭成立或在其他適當情況下,相 關訂約方可向香港、開曼群島、中 國及本公司及沃學主要資產所在地 之法院尋求臨時禁令濟助或其他臨 時補救措施。

董事會將繼續定期審查可變利益實 體架構,並確定本集團在透過可變 利益實體協議保護其持有的資產方 面是否遇到任何問題。倘出現任何 重大問題或困難,董事會將繼續問 助本集團處理相關問題或困難。截 至二零二一年十二月三十一日,本 集團並未就有關可變利益實體協議 的風險購買任何保險。



Despite the above, as advised by the PRC legal advisers to the Company, the VIE Structure is in compliance with and, to the extent governed by the PRC laws currently in force, are enforceable under, the current PRC laws. The Company will continue to monitor the relevant PRC laws and regulations relevant to the VIE Structure and will take all necessary actions to protect the Company's interest in the Structured Entity.

UNWINDING OF THE VIE AGREEMENT

Since the new education regulations incorporating the Opinions (issued in August 2021 by the Beijing Municipality Government) governing the after school tutoring educational activities might have lasting impacts and detrimental effects on the future operation of the Company's subsidiary group of online education under the VIE structure, and with reference to the voluntary announcement of the Company dated 28 December 2021 in relation to update on business operations, the Company decided to undergo organizational restructuring of the education business segment by having Wowxue become a wholly-owned subsidiary of the Company, so that we can continue to provide different kind of educational services and to develop new market in the PRC education industry. In early 2022, Wowxue has surrendered the ICP licenses to the China government for its cancellation in compliance with the new education regulations. After surrendered the ICP licenses, Wowxue's shareholders and directors have signed a legally-bound undertaking which they all irrevocably undertake to the Company that they will assist the organizational restructuring till completion after the VIE terminated.

解除可變利益實體協議

由於納入規管校外培訓教育活動的意見 (由北京市政府於二零二一年八月頒佈) 的新教育法規可能對本公司的線上教育附 屬公司集團於可變利益實體架構下的未來 營運產生持續影響及不利影響,以及經參 考本公司日期為二零二一年十二月二十八 日有關業務營運最新情況的自願公佈,本 公司決定通過將沃學成為本公司的全資附 屬公司對教育業務分部進行組織重組,以 便我們能夠繼續提供不同類型的教育服 務,並在中國教育行業發展新市場。於二 零二二年初,沃學已遵守新教育法規向中 國政府交回互聯網內容供應商牌照以供註 銷。於交回互聯網內容供應商牌照後,沃 學股東及董事已簽署一份受法律約束的承 諾,彼等均不可撤銷地向本公司承諾,彼 等於可變利益實體協議終止後將協助組織 重組直至完成重組。



Up to 31 December 2022, the restructure of Wowxue was still undergoing with all the VIE Agreements been terminated. However, after sought legal opinions from the PRC lawyers, at the time of finalizing this annual report, the Company still have an absolute overall control of Wowxue through the legally-bound undertaking signed by Wowxue's shareholders and directors. However, there are unexpected delay in the progress than to our original schedule time of restructure procedures, due to the pandemic outbreak of Covid-19 variants in China last year. The Company expects Wowxue become the wholly-owned subsidiary of the Company under the restructuring framework by the second half of 2023.

CONNECTED TRANSACTION (INCLUDING CONTINUING CONNECTED TRANSACTION)

In this Annual Report relating to the VIE Agreements. Mr. Zhu Min is one of the beneficial owners of Wowxue. Thus, Wowxue is an associate of Mr. Zhu and is a connected person of the Company under Chapter 14A of the Listing Rules. The VIE Agreements constitute continuing connected transactions of the Company under Chapter 14A of the Listing Rules, and is subject to the reporting, announcement and Independent Shareholders' approval requirements under Chapter 14A of the Listing Rules. The Stock Exchange has granted a waiver to the Company from (i) setting maximum aggregate annual caps for the service fees payable by Wowxue to Huzhou Company under the Management Services Agreement and the loan(s) to be made available by Huzhou Company under the Loan Agreement pursuant to Rule 14A.53 of the Listing Rules; and (ii) setting a fixed term for each of the VIE Agreements (other than the Management Services Agreement) pursuant to Rule 14A.52 of the Listing Rules, subject to certain conditions.

直至二零二二年十二月三十一日,沃學的 重組仍在進行中,所有可變利益實體協議 均已告終止。然而,經尋求中國律師的法 律意見後,於本年報定稿時,本公司仍透 過沃學股東及董事簽署的法律約束承諾對 沃學擁有絕對整體控制權。然而,由於去 年中國爆發Covid-19變種病毒,重組程序 的進度較原定時間表意外延遲。本公司預 期,沃學根據重組框架學將於二零二三年 下半年前成為本公司之全資附屬公司。

關連交易(包括持續關連交易)

於此與可變利益實體協議有關的年報中, 朱敏先生為沃學的實益擁有人之一。因 此,沃學為朱先生的聯繫人,及根據上 市規則第十四A章,其為本公司的關連人 士。可變利益實體協議構成上市規則第十 四A章項下本公司之持續關連交易,故須 遵守上市規則第十四A章項下的申報、公 告及獨立股東批准規定。本公司已獲聯交 所授予豁免(i)根據上市規則第14A.53條就 沃學根據管理服務協議應付湖州公司之服 務費用及湖州公司根據貸款協議將授出的 貸款列出最高總年度上限;及(ii)根據上市 規則第14A.52條列出各可變利益實體協議 的固定條款(除管理服務協議以外),惟 須遵守若干條件。



For the year ended 31 December 2021, the total amount of service fees paid by Wowxue to Huzhou Company under the Management Services Agreement was approximately RMB2,268,000 and the total amount of loans made available by Huzhou Company under the Loan Agreement was nil.

Pursuant to Rule 14A.71(6), the independent non-executive directors of the Company have reviewed and confirmed that the transactions under the VIE Agreements had been entered into in the ordinary and usual course of business of the Group, on normal commercial terms or better, and according to the agreement governing them on terms that are fair and reasonable and in the interests of the Company's shareholders as a whole. Based on the work performed, the auditor of the Company has confirmed in a letter to the Board that nothing has come to their attention that causes them to believe that the transactions under the VIE Agreements (i) have not been approved by the Board; (ii) were not, in all material respects, in accordance with the pricing policies of the Group for transactions involved the provision of goods and services by the Group; (iii) were not entered into, in all material respects, in accordance with the terms of the relevant agreements governing such transactions; and (iv) no dividends or other distributions have been made by Wowxue to the holders of its equity interest which are not otherwise subsequently assigned or transferred to the Group.

In respect of the connected transaction announced on 9 July 2019 relating to financial assistance by connected persons, the principal amount of the financial assistance was HK\$226,416,000 in total. The Company entered into the deed of amendment with the vendors to extend the maturity date of the promissory note (PN1) to 9 July 2021 and decrease the interest rate from 2% to 1% per annum effective from 9 July 2019. Then, On 2 December 2020, the Company entered into the deed of amendment with the vendors to extend the maturity date of the PN1 to 1 April 2022 and the interest rate remained to 1% per annum effective from 2 December 2020. The PN1 composed of two portions, namely PN1(a) and PN1(b); and PN1(a) was issued to Wide Select with Mr. Lee as its beneficiary, and PN1(b) to Win All with Mr. Ng as its beneficiary.

根據上市規則第14A.71(6)條,本公司之 獨立非執行董事已審閱及確認可變利益實 體協議項下之交易乃於本集團一般及日常 業務過程中,按正常或更佳商業條款,並 根據規管交易之協議按屬公平合理且符合 本公司股東整體利益之條款訂立。根據已 實行之工作,本公司核數師已於致董事會 之函件中確認,彼等並無注意到任何事宜 令彼等相信可變利益實體協議項下之交易 (i)未經董事會批准;(ii)於各重大方面並無 遵守本集團提供貨品及服務所涉及交易之 定價政策;(iii)於各重大方面並無根據規管 該等交易之相關協議之條款訂立;及(iv)沃 學並無向其後並未轉移或轉讓其所持有股 權至本集團之股權持有人分派股息或作出 其他分派。

根據於二零一九年七月九日宣佈有關關連 人士提供的財務資助之關連交易,財務 資助之本金總額為226,416,000港元。本 公司與賣方訂立修訂契據,將承兑票據 (PN1)之到期日延長至二零二一年七月 九日,並自二零一九年七月九日起將年利 率由2%減至1%。其後,於二零二零年十 二月二日,本公司與賣方訂立修訂契據, 將PN1 之到期日延長至二零二二年四月 一日,並自二零二零年十二月二日起將 年利率維持於1%水平。PN1由兩部分組 成,即PN1(a)及PN1(b);而PN1(a)乃發行 予Wide Select,李先生為其受益人,而 PN1(b)乃發行予Win All,吳先生為其受益 人。

On 30 June 2021, the Company extended the maturity date of PN1 to 31 March 2023 with the PN1 holders. During the year 2021, both the PN1(a) and PN1(b) holders had partly redeemed their PN1 principal amount in their name of Wide Select and Win All, and the remaining balance of principal amounts as at 29 December 2021 in PN1(a) and PN1(b) were respectively, HK\$98,208,000 and HK\$73,208,000. On 30 December 2021, the Company has formed new PNs with the PN holders to replace the old PNs, and the remaining principal of both PN1(a) and PN1(b) had respectively became part of total principal amounts of the New PN1 and New PN2 (Details refer to Note 35 of the Consolidated Financial Statement of the annual report).

In respect to the connected transaction of the Share Purchase Agreement with Cybernaut Education Limited (the "vendor") on 26 July 2017, there was a profit guarantee by the vendor for the 4th period of six months ending 31 December 2019. The Company received the Auditor's Certificate confirming that the 4th guaranteed profit for the 4th guaranteed period had been fulfilled in the business and set out in note 35. Accordingly, the Company issued the 4th Promissory Note in the principal amount of HK\$55 million to the Vendor or its nominee(s) during the year ended 31 December 2020 as set out in note 35, for the partial settlement of the Consideration pursuant to the Sale and Purchase Agreement dated 26 July 2017 which constitutes a discloseable connected transaction as defined under the Listing Rules.

於二零二一年六月三十日,本公司與PN1 持有人將PN1之到期日延長至二零二三年 三月三十一日。於二零二一年內,PN1(a) 及PN1(b)持有人均以其各自的名義贖回其 於Wide Select及Win All的部分PN1本金 額,而PN1(a)及PN1(b)於二零二一年十二 月二十九日的本金餘額分別為98,208,000 港元及73,208,000港元。於二零二一年 十二月三十日,本公司已與PN持有人組 成新承兑票據,以取代舊承兑票據,而 PN1(a)及PN1(b)的餘下本金已分別成為新 PN1及新PN2本金總額的一部分(詳情請 參閱本年報綜合財務報表附註35)。

在與Cybernaut Education Limited (「賣 方」) 於二零一七年七月二十六日訂立的 購股協議之關連交易中,賣方就截至二零 一九年十二月三十一日止六個月的第四個 期間訂有溢利保證。本公司接獲核數師證 明書,證明第四個保證期間的第四保證溢 利已於業務過程中獲達成,詳情載於附註 35。因此,誠如附註35所載,本公司於 截至二零年十二月三十一日止年度 根據日期為二零一七年七月二十六日之 買賣協議向賣方或其提名人發行本金額 55,000,000港元之第四批承兑票據,用 於支付部分代價,其構成上市規則項下所 定義之須予披露關連交易。



RELATED PARTY TRANSACTION

All the related party transactions disclosed in Note 37 to the Consolidated Financial Statement in this 2022 Annual Report constituted connected transactions of the Company under Chapter 14A of the Listing Rules but were all fully exempt from shareholders' approval, annual review and all disclosure requirements. The Company confirmed that where any related party transactions constituted connected transactions under Chapter 14A of the Listing Rules, the Company has complied with all requirements under Chapter 14A of the Listing Rules.

EVENT AFTER THE REPORTING PERIOD

Granting of loans

On 18 January 2023 and 21 February 2023, Time Credit Limited, a subsidiary of the Company, entered into the loan agreements with the borrowers pursuant to which the lender has agreed to grant the loans in the principal amount of HK\$8 million and HK\$19 million to the borrowers, respectively.

Further details regarding the grant of loans are disclosed in the announcements of the Company dated 18 January 2023 and 21 February 2023, respectively.

Save as disclosed the above, there were no other significant events occurred subsequent to December 31, 2022 and up to the date of this annual report.

HUMAN RESOURCES AND STAFF REMUNERATION

As at 31 December 2022, the Group had about 47 staff members employed in mainland China and Hong Kong (2021: 83). Total staff costs for the year were approximately RMB11.5 million (2021: RMB13.8 million). During the year, the Group continued to reinforce the training to its staff by providing training and study opportunities for management staff and professional technicians. In addition, the Group has provided a timely update to all staff about the latest government policies of the industry to continuously enhance the professional standard and quality of the staff.

Meanwhile, the Group has provided competitive remuneration for staff which encourages them to commit themselves and serve customers wholeheartedly. The Group operates share option scheme for the purpose to provide incentives and rewards to eligible directors and employees of the Group who contribute to the success of the Group's operations. The Group granted 120 million share options to the eligible consultants of the Company during the financial year as announced on 9 September 2022. The remuneration payable to the senior management of the Company (excluding Directors and Chief Executive Officer) for the year ended 31 December 2022 was determined with reference to their position, responsibilities and experience and prevailing market condition.

於二零二二年十二月三十一日,本集團於 中國大陸及香港合共聘用約47名員工(二 零二一年:83名)。本年度的員工成本總 額約為人民幣11,500,000元(二零二一 年:人民幣13,800,000元)。年內,本集 團繼續加強員工培訓工作,向管理人員和 專業技術人員提供培訓及學習的機會。此 外,本集團亦即時向所有員工傳達政府的 最新行業政策方面的資訊,不斷提高員工 的專業水平及質素。

同時,本集團還向其員工提供有競爭力之 薪酬,鼓勵彼等全心全意為客戶服務。 本集團設有一項購股權計劃,目的是向 對本集團營運的成功作出貢獻之本集團 合資格董事及僱員提供獎勵及報酬。如 二零二二年九月九日所公佈,於該財政 年度,本集團向本公司的合資格顧問授出 120,000,000份購股權。截至二零二二年 十二月三十一日止年度,應付本公司高級 管理層(不包括董事及行政總裁)薪酬乃 參照彼等之職位、職責及經驗以及現行市 況所釐定。

COMPLIANCE WITH MONEY LENDERS ORDINANCE (CHAPTER 163 OF THE LAWS OF HONG KONG) (THE "MLO")

Our money lending business is required to and has, at all times, strictly complied with all relevant laws and regulations. In the opinion of our Directors, in addition to the Rules Governing the Listing of Securities (the "Listing Rules") on The Stock Exchange of Hong Kong Limited (the "Stock Exchange"), MLO constituted a significant influence on our Group's money lending business during the year. The MLO is the principal ordinance which governs the money lending business in Hong Kong. Our money lending business has been conducted through the subsidiary of our Company. Since the first granting of money lenders licence to our subsidiary, we have never received any objection from and have never been investigated by the Registrar of Money Lenders nor the Commissioner of Police regarding the renewal of the money lenders licence. To the best of our knowledge, our Group has complied with the MLO in all material aspects, and that our Directors are not aware of any matters that might come to their attention that our money lenders licence would be suspended, terminated or would not be renewed in foreseeable future.

Our money lending segment's main target customers are high net worth individual, corporations and other licensed money lenders through referral from business networks. Most of loans are secured by first legal charge over properties in Hong Kong. The credit risk assessment of customers we conducted involves obtaining land search and valuation report from professional surveyors on properties; ascertaining the financial condition of the customers including reviewing income/ asset proof of individual customers and financial reports of corporate customers; and conducting litigation and bankruptcy searches and credit search on customers. The loan terms are determined with reference to factors including customers' requirements; result of credit assessment of customers, including whether regular income of customers are sufficient to cover loan repayment instalments; value of collaterals; prevailing market interest rates for similar loans and our credit policy. The Company has adopted the procedures on monitoring loan

我們的放債業務須於並已於任何時間嚴格 遵守所有相關法律及法規。董事認為, 除香港聯合交易所有限公司(「聯交所」) 證券上市規則(「上市規則」)外,於本年 度,放債人條例對本集團之放債業務構成 重大影響。放債人條例為規管香港放債業 務之主要條例。我們的放債業務乃透過不 司之附屬公司進行。自我們的附屬公讀 貧放債人牌照專宜接獲放債人註冊處處 到於債人牌照以來,我們從未就續 領放債人牌照多出之任何反對或受其詞 查。據我們所深知,本集團已於各重大方 面遵守放債人條例,且董事並不知悉任何 事宜可導致我們之放債人牌照於可見將來 遭吊銷、終止或不獲重續。

我們借貸分部的主要目標客戶為高淨值個 人、企業及其他通過商業網絡推薦的持牌 放債人。大部分貸款均以香港物業的首次 法定抵押作抵押。我們對客戶進行的信貸 風險評估涉及向專業物業測量師取得土地 查冊及估值報告;確定客戶的財務狀況, 包括審閱個別客戶的收入/資產證明及 企業客戶的財務報告;及對客戶進行訴訟 及破產調查以及信貸調查。貸款條款乃參 考多個因素釐定,包括客戶要求;客戶的 信貸評估結果,包括客戶的定期收入是否 足以支付貸款分期還款;抵押品價值;類 似貸款的現行市場利率及我們的信貸政 策。本公司已採納監察貸款還款及收回之 程序,當中涉及(a)我們的借貸分部直接由 本公司一名執行董事管理,該名執行董事 須於每月結束後向董事會提交每月管理賬



repayment and recovery which involve (a) our money lending segment was directly managed by an executive director of the Company who is required to submit monthly management accounts to the Board after the end of each month and to report to the Board on the financial and business performance during review meetings at least semi-annually; (b) the executive director is required to report to the Board on the repayment status of all loans on a monthly basis and to report any material defaulted loans immediately upon occurrence. In respect of delinquent loans, we will first issue standard demand letters. If no satisfactory response is received, we will instruct solicitors to issue formal legal demand letters. Thereafter formal legal proceedings may be issued where appropriate.

FUTURE PROSPECTS

According to the report of the January 2023 World Economic Outlook (WEO) Update by the International Monetary Fund (IMF), amid the cost-of-living crisis, the priority remains achieving sustained disinflation in most economies. The tighter monetary conditions and lower economic growths potentially affect the country's financial and debt stability, and it is necessary for the countries to deploy macroprudential tools and strengthen debt restructuring frameworks. It is expected that the accelerating Covid-19 vaccinations in China would further safeguard the global economic recovery in 2023, with the positive crossborder spillovers. Fiscal support to countries should be better targeted at those that are most affected by the elevated food and energy prices, and the broad-based fiscal relief measures should be withdrawn.

As the Asian financial hub, Hong Kong has been hit quite badly by its own pandemic measures since 2020; and the spillover from China's Covid-19 zero policy, while risks from cost pressure persisted in the economy during 2022. Mr. Christopher Hui, the Secretary for Hong Kong Financial Services and the Treasury has once said that the Government's plan is to lower the statutory interest rate cap for lending after having taken into consideration of the recommendations from the Consumer Council, the effective interest rate cap for lending overseas, as 目,並至少每半年於檢討會議上向董事會 報告財務及業務表現;(b)該名執行董事須 每月向董事會報告所有貸款之還款狀況, 並於發生任何重大拖欠貸款時即時報告。 就拖欠貸款而言,我們將首先發出標準催 款函。倘並無收到滿意回覆,我們將指示 律師發出正式法律催款函。其後,可在適 當情況下提出正式法律程序。

展望

根據國際貨幣基金組織發佈的二零二三年 一月最新的《全球經濟展望》報告,在生 活成本危機期間,大多數經濟體的優先事 項仍在實現持續的惡性通脹。貨幣環境收 緊及經濟增長放緩可能影響國家的金融及 債務穩定性,且國家有必要部署宏觀審 且及加強債務重組框架。隨著跨境溢出 效應的顯現,預計二零二三年中國加速 Covid-19疫苗接種將進一步保障全球經濟 的復甦。向國家提供的財政支援更應給予 最受食品及能源價格上升影響的國家,並 應撤銷廣泛的財政救濟措施。

作為亞洲金融中心,香港自二零二零年起 受到其自身疫情措施的沉重打擊;加上中 國Covid-19清零政策的外溢效應,二零二 二年經濟仍面臨成本壓力帶來的風險。香 港財經事務及庫務局局長許正宇先生曾表 示,經考慮消費者委員會的建議、本地放 債行業採納的實際利率、海外放債的利率 上限以及其他市場統計數據後,政府計劃 降低放債的法定利率上限。香港銀行於二 零二二年已三次上調最優惠利率,合共增

well as other market statistics. And the banks in Hong Kong had already increased their prime rate of interest three times in 2022, by a total of 62.5 basis points to 4.75 percent. On February 2, 2023 the Hong Kong Monetary Authority (HKMA) raised the interest rate by 25 basis points to 5.0 percent, just hours after the U.S. Fed delivered a rate hike of a similar margin. Hong Kong will continue to have an active and growing money-lending market. The lending business segment of the Cybernaut Group, TCL will continue granting mortgage loan to clients in a prudent manner, so the subsidiary business can well meet the needs for the Hong Kong property market accordingly.

The eCommerce market has evolved from a simple counterpart of brick and mortar retail to a shopping ecosystem that involves multiple devices and store concepts. By viewing at the eCommerce landscape we can see a relatively mature business market with established players and a clear set of rules in the market. However, this impression can be misleading, as the digital transformation of eCommerce business is not over yet, and it is unlikely to ever come to a halt for it, mainly driven by the flow of innovation coming from numerous start-ups and the growing cashflow from the fast-developing Asian economies.

Despite the slowing Chinese economy since the outbreak of the Covid-19, there is a shift in purchasing power from the U.S. and Europe to China and Southeast Asia, and such a change were fueled by the growing number of consumers gaining access to eCommerce due to the growing purchasing power and internet penetration, especially through the application with mobile devices. In the coming few years, the Chinese eCommerce market is expected to show the largest growth rates amongst the three major eCommerce regions in the globe. We believe that many online retailers will continue to choose an omnichannel sales strategy in 2023. To meet the competitiveness in the industry, our subsidiary VTZero has not just moving beyond competing on price, but also on logistics etc.; and vary business tactics will be adopted by the subsidiary to strive for its business operation and survival in the highly competitive eCommerce environments.

儘管自Covid-19爆發以來中國經濟放緩, 但購買力從美國及歐洲轉移至中國及東南 亞,且有關變動乃由於購買力及互聯網滲 透率(尤其是透過移動設備應用)不斷提 高導致越來越多消費者接觸電子商務所 致。於未來數年,預期中國電子商務市場 將在全球三大電子商務地區中呈現最大增 長率。我們相信,許多線上零售商將於二 零二三年繼續選擇全渠道銷售策略。為了 在行業中保持競爭力,我們的附屬公司 VTZero要在價格及物流方面競爭;附屬 公司將採取不同的業務策略,以在競爭激 烈的電子商務環境中促進其業務營運及生 還。



It is noted by Economists that China will further tighten oversight over its battered online education sector, in a clear signal that the Beijing government is not yet prepared to unshackle the private tutoring arena despite loosening curbs on the tech giants. The Chinese government has pledged to address outstanding issues in the quality, safety, standards and pricing of tutoring services to alleviate household financial burdens. And all tutoring firms will be required to meet the new educational regulatory standards of tutoring services in China by June 2023. For any organizations with business engaged in the non-curriculum tutoring in China, their services rendered must strictly comply with the updated guidelines under the revised educational laws and related regulatory measures for their business development. Under the China shuangjian reforms on education and the new education regulation governing on after school education and tutoring business activities, our management has to seek changes for the survival of our online education business in China. The Company is still undergoing procedures to restructure Wowxue into our subsidiary group, so that we can resume business operation in the education sector in compliance with the regulatory requirements after the completion of the corporate restructuring.

In early 2023, the Company has established a joint venture subsidiary for project business to explore in the areas of satellite-related applications utilizing the telecommunication, navigation and remote sensing technologies. The subsidiary named "PTF AreaTech" is providing intelligent technology solutions consisting of various types of satellite positioning terminals equipment (compatible with GNSS raw data from Beidou, GPS, Galileo, GLONASS and QZSS) and customized solutions with spatial-intelligent service system with high precision positioning service to clients. With the fast growing of 5G, AI, big data and cloud computing technology, PTF AreaTech strives to empower the upgrading of all kinds of industries including construction, agriculture and marine, energy, logistics and intelligent driving, smart city development, and disaster management, etc., for clients engaged in different industries and from different countries.

於二零二三年初,本公司已就項目業務成 立一間合營附屬公司,以利用電信、導 航及遙感技術探索衛星相關應用領域。 附屬公司名為「PTF AreaTech」,為客戶 提供各種衛星定位終端設備(兼容北斗、 GPS、Galileo、GLONASS及QZSS的全 球衛星導航系統原始數據)的智能技術解 決方案,以及具備高精準定位服務的空 間智能服務系統的定製解決方案。隨著 5G、人工智能、大數據及雲計算技術的 快速發展,PTF AreaTech致力於為來自 不同行業及不同國家的客戶賦能建築、農 業與海洋、能源、物流與智能駕駛、智慧 城市發展、災害治理等各類產業的升級。

The relevant risk management strategy would be applied to each type of risks according to the assessment results, type of risk management strategy has been listed as follow:

- Risk retention and reduction: accept the impact of risk or undertake actions by the Group to reduce the impact of the risk;
- Risk avoidance: change business process or objective so as to avoid the risk;
- Risk sharing and diversification: diversify the effect of the risk or allocate to different location, product or market;

INTRODUCTION

Cybernaut International Holdings Company Limited (the "Company", together with its subsidiaries, the "Group") adopts a diversified business development strategy and has established its firm footing in three business segments, namely (i) money lending business, (ii) eCommerce business and (iii) internet online education services. This Environmental, Social and Governance Report (the "ESG Report") summarises the environmental, social and governance ("ESG") initiatives, plans and performances of the Group and demonstrates its commitment to sustainable development.

ESG Governance Structure

The Group has established the ESG working taskforce (the "Taskforce"). The Taskforce composes of full-time staff from relevant departments and is responsible for collecting relevant information on the ESG aspects for preparing the ESG Report. The Taskforce at least annually reports to the board (the "Board") of directors (the "Directors"), assists in identifying and assessing the Group's ESG risks and the effectiveness of the internal control mechanisms. The Taskforce also examines and evaluates the Group's performances in different aspects, such as environmental protection, labour practices, and other ESG aspects. The Board has the overall responsibility for the Group's ESG issues, including setting the general direction for the Group's ESG strategies, ensuring the effectiveness of risk management and internal control mechanisms. The Board discusses the Group's ESG issues at least annually. In response to the goal of carbon neutralisation by the governments in the Group's operating locations and to fulfil the Group's commitment to sustainable development, the Group set targets in the financial year ended 31 December 2021 ("FY2021") to reduce Greenhouse Gas ("GHG") emissions, electricity usage, water consumption and waste disposal.

REPORTING PERIOD

The ESG Report specifies the ESG activities, challenges and measures taken by the Group during the financial year ended 31 December 2022 ("FY2022" and "Reporting Period").

序言

賽伯樂國際控股有限公司(「本公司」,連 同其附屬公司統稱「本集團」)採納多元化 的業務發展策略,於三個業務分部(即(i) 放債業務、(ii)電子商務業務及(iii)互聯網 線上教育服務)奠定了堅實的基礎。本環 境、社會及管治報告(「環境、社會及管治 報告」)總結本集團在環境、社會及管治 (「環境、社會及管治」)上的倡議、計劃 及績效,並展示其在可持續發展方面的承 諾。

環境、社會及管治治理結構

本集團已成立環境、社會及管治工作小 組(「工作小組」)。工作小組由相關部門 的全職員工組成,負責搜集在環境、社會 及管治方面的相關資料以編製環境、社會 及管治報告。工作小組會至少每年向董 事(「董事」)會(「董事會」)彙報,協助辨 識和評估本集團的環境、社會及管治風險 以及內部控制機制的有效性。工作小組亦 會檢查和評估本集團在環境保護、勞工常 規以及環境、社會及管治其他方面等不同 方面的表現。董事會則對本集團的環境、 社會及管治事宜整體負責,包括設定本集 围環境、社會及管治策略上的大方向,並 確保風險管理及內部控制機制的有效性。 董事會至少每年討論本集團的環境、社會 及管治事宜。為響應本集團營運所在地政 府的碳中和目標,並履行本集團對可持續 發展的承諾,本集團於截至二零二一年十 二月三十一日止財政年度(「二零二一財 年」)設定目標,以減少溫室氣體(「溫室 氣體」)排放、用電量、用水量及廢棄物處 理。

報告期間

環境、社會及管治報告説明本集團截至二 零二二年十二月三十一日止年度(「二零二 二財年」及「報告期間」)在環境、社會及 管治層面的活動、挑戰及所採取的措施。



SCOPE OF REPORTING

For FY2022, the reporting scope of the ESG Report is the same as that of Annual Report 2022. The key performance indicators ("KPIs") are gathered and cover companies and subsidiaries that are under the Group's direct operational control. The KPIs are shown in the ESG Report and are supplemented by explanatory notes to establish benchmarks.

REPORTING FRAMEWORK

The ESG Report has been prepared in accordance with Environmental, Social and Governance Reporting Guide (the "ESG Reporting Guide") as set out in Appendix 27 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited ("HKEX"). Information relating to the Group's corporate governance practices can be found in the Corporate Governance Report on the Annual Report 2022.

REPORTING PRINCIPLE

During the preparation for this ESG Report, the Group has applied the reporting principles in the ESG Reporting Guide as follow:

Materiality: Materiality assessment was conducted to identify material issues during the Reporting Period, thereby adopting the confirmed material issues as the focus for the preparation of the ESG Report. The materiality of issues was reviewed and confirmed by the Board and senior management. For further details, please refer to the sections headed "Stakeholder Engagement" and "Materiality Assessment".

Quantitative: The standards, methodologies and applicable assumptions used in the calculation of KPIs data were supplemented by explanatory notes.

Consistency: Unless otherwise stated, the preparation approach of this ESG Report is consistent with the previous year, including FY2021 for comparison. If there are any changes in the scope of disclosure and calculation methodologies that may affect comparison with previous reports, explanations will be provided to the corresponding data.

報告範圍

報告框架



A. ENVIRONMENTAL

A1. Emissions

The Group realises that environmental protection relies on both collective and individual efforts and is also concerned whether its funds might be diverted to enterprises that cause serious environmental impacts or have little concern over sustainability. Thus, the Group continuously improves existing policies and incorporates new policies with the intention of mitigating potential direct and indirect negative environmental impacts arising from its business operations and makes a conscious effort to avoid diverting funds to non-environmentally conscious enterprises.

The Group was not aware of any material non-compliance with laws and regulations, including but not limited to, the Waste Disposal Ordinance of Hong Kong, the Environmental Protection Law of the People's Republic of China, the Prevention and Control of Environmental Pollution by Solid Waste of the People's Republic of China, the Water Pollution Prevention and Control Law of the People's Republic of China and the Prevention and Control of Atmospheric Pollution of the People's Republic of China from the People's Republic of China ("China")'s that would have a significant impact on the Group during FY2022.

A. 環境

A1. 排放物

本集團意識到環境保護有賴於 集體和個人的共同努力,亦擔 憂其資金是否可能轉移至造成 嚴重環境影響或不注重可持 續發展的企業。因此,本集團 持續完善現有政策及引入新政 策境造成的直接及間接負面 影響,並致力避免將資金轉移 至無環保意識的企業。

於二零二二財年,本集團並不 知悉任何會對本集團造成重大 影響的重大違法違規情況,該 等法律法規包括但不限於香港 的《廢物處置條例》及中華人民 共和國環境保護法》、《中華人民 共和國環境保護法》、《中華人民 民共和國固體廢物污染環境防 治法》、《中華人民共和國水污 染防治法》及《中華人民共和國 大氣污染防治法》。

Air Emissions

Due to the Group's business nature, the Group considers that air emissions generated are of an insignificant level.

GHG Emissions

The principal GHG emissions of the Group were generated from petrol consumption by vehicles (Scope 1), purchased electricity (Scope 2), and paper waste disposal (Scope 3).

Scope 1 – Direct GHG Emissions

The Group has adopted the following measures to mitigate direct GHG emissions from petrol consumption by vehicles in its operations;

- Plan routes ahead of time to avoid route repetition and optimise fuel consumption;
- Switch off the engine whenever the vehicle is idling; and
- Regularly service vehicles to ensure optimal engine performance and fuel use.

Scope 2 – Energy Indirect GHG Emissions

Electricity consumption accounted for the largest percentage of GHG emissions within the Group. The Group has implemented measures to reduce energy consumption, such measures are mentioned in "Use of Resources".

廢氣排放

鑒於本集團的業務性質,本集 團認為所產生的廢氣排放量極 低。

溫室氣體排放

本集團的主要溫室氣體排放產 生於汽車消耗汽油(範圍1)、 購買電力(範圍2)以及廢紙處 理(範圍3)。

範圍1-直接溫室氣體排放

本集團已採納以下措施,減緩 營運過程中汽車消耗汽油帶來 的直接溫室氣體排放:

- 事先規劃路線,以免路
 線重複,並改善燃料耗
 用情況;
- 車輛不使用時會關掉引 擎;及
- 定期對車輛進行保養, 確保最佳的引擎表現及 燃料使用情況。

範圍2-能源間接溫室氣體排 放

耗電量所佔本集團溫室氣體排 放量的比例最大。本集團已實 施措施降低能源消耗,該等措 施載於「資源使用」。



Scope 3 – Other Indirect GHG Emissions

Paper waste disposal is accounted for the other indirect GHG emissions. Measures implemented to reduce paper waste disposal and air travel can be found in the sections headed "Waste Management" and aspect A2 "Use of Resources" respectively.

In FY2021, the Group set a target to host related environmental campaigns, such as training and seminars, to raise employees' awareness of GHG emissions reduction in FY2022. In order to comply with the pandemic control measures, the Group did not host any environmental campaigns related to reduce GHG emissions during the Reporting Period. However, the Group continues to monitor the level of GHG emissions and implements relevant measures mentioned above. During the Reporting Period, the Group sets a target to host at least one environment-related campaign, such as training and seminars, in the financial year ends 31 December 2023 ("FY2023").

The GHG emissions intensity decreased significantly from approximately 1.42 tCO_2e /employee in FY2021 to approximately 1.35 tCO_2e /employee in FY2022. The Group will continue to actively promote environmentally friendly measures to help reduce GHG emissions.

<u>範圍3-</u>其他間接溫室氣體排 放

其他間接溫室氣體排放產生於 廢紙處理。為減少廢紙處理量 及飛機出行次數而實施的措施 分別載於「廢棄物管理」及層面 A2「資源使用」各節。

於二零二一財年,本集團設立 目標在二零二二財年舉辦環保 相關的活動,如培訓及研討 會,以提高員工對溫室氣體 辦的認識。為遵守疫情控制措 施,本集團於報告期間並無舉 辦任何有關減少溫室氣體排並無舉 辦任何有關減少溫室氣體排放水平, 實施上述相關措施。於報告期 間,本集團設定目標於截至二 零二三年十二月三十一日止財 政年度(「二零二三財年」)舉辦 至少一次環境相關活動,如培 訓及研討會。

溫室氣體排放密度由二零二一 財年的約1.42噸二氧化碳當 量/僱員大幅減少至二零二 二財年的約1.35噸二氧化碳當 量/僱員。本集團將繼續積極 推行環保措施,以助減少溫室 氣體排放。

Discharges into Water and Land

Due to the Group's business nature, the discharges into land are insignificant. Similarly, there has not been a significant and unreasonable amount of water discharged; used water was discharged via the municipal sewage network to the regional water treatment plant.

Waste Management

Hazardous Waste Handling Method

Due to the Group's business nature, no material hazardous waste was generated by the Group during FY2022.

Non-hazardous Waste Handling Method

The majority of non-hazardous waste generated by the Group was general waste. Though there has not been a disproportional amount of waste produced, the Group places great effort in encouraging the employees to reduce waste production by adopting the following environmentally friendly initiatives:

- Recycle used single-sided office paper;
- Double-sided printing or photocopying; ٠
- Print electronic correspondences only when • necessary;
- Procure office paper with Forest Stewardship Council Recycled Label; and
- Recycle office and electronic equipment after their life cycle.

廢棄物管理

有害廢棄物處理方法

由於本集團的業務性質,本集 團於二零二二財年並無產生重 大有害廢棄物。

無害廢棄物處理方法

本集團產生的大部分無害廢棄 物為一般垃圾。儘管未產生過 多的廢棄物,本集團仍致力鼓 勵僱員透過採取下列環保舉措 減少廢棄物產生:

- 循環使用用過的單面辦 • 公用紙;
- 雙面打印或複印; ٠
- 僅於必要時打印電子信 丞;
- 購買帶有森林管理委員 會回收標誌的辦公用 紙;及
- 於辦公及電子設備的生 命週期後對其進行循環 使用。

In FY2021, the Group set a target to host waste reduction related campaigns to raise employee awareness of waste reduction in FY2022. In order to comply with the pandemic control measures, the Group did not host any waste reduction campaigns during the Reporting Period. However, the Group continues to monitor the level of waste generation and implements relevant measures mentioned above. During the Reporting Period, the Group sets a target to host at least one waste reduction campaign in FY2023.

The non-hazardous waste intensity in FY2022 was similar to that in FY2021. The Group considers current paper-saving measures are effective in increasing the employees' awareness of reducing the use of non-hazardous waste disposal amount.

A2. Use of Resources

The Group takes the initiative to introduce green measures to reduce environmental impact arising from its business operations. Measures on reducing office paper waste have been mentioned in the preceding "Waste Management" section. Other initiatives include maintaining indoor temperature at a suitable level in the offices and promoting the use of teleconferences or video conferences to replace the needs for constant business air travel.

A2. 資源使用

本集團主動推出環保措施以降 低其業務營運造成的環境影 響。減少辦公用紙的措施已於 前文「廢棄物管理」一節闡述。 其他舉措包括將辦公室的室內 温度維持在合適的水平,並提 倡採用電話會議或視頻會議形 式,以代替需要經常性乘坐飛 機出外公幹。



目標在二零二二財年舉辦減少 廢物相關的活動,以提高員工 對減少廢物的意識。為遵守 疫情控制措施,本集團於報告 期間並無舉辦任何減廢活動。 然而,本集團繼續監察廢棄物 產生水平,並實施上述相關措 施。於報告期間,本集團設定 目標於二零二三財年舉辦至少 一次減廢活動。

於二零二一財年,本集團設立

於二零二二財年的無害廢棄物 密度與二零二一財年相若。本 集團認為目前的節省紙張措施 行之有效,可讓僱員更為注意 減少使用無害廢棄物數量。

Energy Efficiency

The Group has in place a multitude of strategies to reduce resources consumption. However, given the Group's office-based business nature, applicable green measures that could be implemented into the Group's policy are limited. Nevertheless, the Group strives to further reduce energy consumption by adopting energy-saving measures such as the following:

- Switch off unnecessary lightings and electrical appliances when not in use;
- Purchase energy-efficient equipment on replacement of old equipment;
- Set all computer screens and printers to standby mode after a certain period; and
- Post eye-catching stickers on energy efficiency as a reminder for employees.

In FY2021, the Group set a target to participate in energy-saving related campaigns to raise employees' awareness of energy-saving in FY2022. In order to comply with the pandemic control measures, the Group did not host any energy-saving related campaigns during the Reporting Period. However, the Group continues to monitor the level of energy consumption and implements relevant measures mentioned above. During the Reporting Period, the Group sets a new target to host at least one energy saving campaign in FY2023.

於二零二一財年,本集團設立 目標在二零二二財年參加節約 能源相關的活動,以提高員工 對節約能源的意識。為遵 方 控制措施,本集團於報告 期間並無舉辦任何節能相關 動。然而,本集團縱續監察能 調消耗水平,並實施上述相關 定新目標於二零二三財年舉辦 至少一次節能活動。



Unexpected high consumption of electricity will be investigated to find out the root cause and preventive measures will be taken. The energy consumption intensity decreased by approximately 13% from approximately 2,491.67 kWh/employee in FY2021 to approximately 2,178.59 kWh/employee in FY2022. This was mainly due to the decrease in the overall time spent by employees in the office as a result of the COVID-19 pandemic.

Summary of energy consumption performance:

Water Consumption

Due to the Group's business nature, water was mainly used for the daily needs of employees and the cleaning and sanitation of the offices. The Group did not consider the amount of water used to be disproportionate.

The Group makes a conscious effort to reduce water consumption by introducing water conservation measures, such as regularly inspects water taps to prevent leakage, installs dual flush water cisterns in toilets and water-saving thimbles in sinks and washrooms where possible. The Group has also posted banners with water-saving messages around the offices in an effort to raise employees' awareness of water conservation.

In FY2021, the Group set a target to host water conservation related campaigns to raise employees' awareness of water conservation in FY2022. In order to comply with the pandemic control measures, the Group did not host any water-saving related campaigns during the Reporting Period. The Group continues to monitor the level of water consumption and implements relevant measures mentioned above. During the Reporting Period, the Group sets a target to host at least one water saving campaign in FY2023.

The water consumption intensity decreased significantly because the water consumption expense in the Shenzhen office was included in the rental fees in FY2022 and the water consumption records for such premise was not available. The Group will continue to monitor the water usage and, where necessary, implement more water-saving measures to manage water usage.

Due to the Group's business nature, the Group did not encounter any problem in sourcing water that is fit for purpose.

Although the Group's business operations do not pose a large impact on the environment, the Group conducts regular assessments on potential environmental risks of its business, adopts preventive measures accordingly and ensures compliance with relevant laws and regulations. The Group will continue to actively seek out other ways to reduce its environmental footprint.

Indoor Air Quality

Poor indoor air quality poses both short-term and long-term threats to the employees. Therefore, the Group remains vigilant in ensuring that the workplace has good indoor air quality, indoor air quality is regularly monitored and measured. To improve indoor air quality, air purifying equipment is used in offices and the air conditioning systems are cleaned periodically. These measures resulted in achieving a satisfactory indoor air quality level.

A4. Climate Change

Extreme weather events are becoming more frequent and severe, while tackling climate change has become a global consensus. The Group has realized that climate change will affect its business operations. Therefore, the Group has established policies and procedures to identify, monitor and manage ESG issues, including climate change. Material climate-related risks are identified and managed under our enterprise risk management framework.

A4. 氣候變化

Climate Change Issues

Following are the climate change risks that will impact the Group's business operations, these risks could be classified as physical risks and transition risks. Physical risks refer to the risks of increased frequency of extreme weather events that could impact the Group's business operations. On the other hand, transition risks refer to the risks of transitioning to a lower-carbon economy which may entail extensive policy, legal, technology, and market changes to address mitigation and adaptation requirements related to climate change. Depending on the nature, speed, and focus of these changes, transition risks may pose varying levels of financial and reputational risks to the Group. Further explanation will be discussed below.

Physical Risks

Increased frequency and severity of extreme weather events such as extreme cold or heat, storms, heavy rains, and typhoons can disrupt operations by damaging the power grids and communication infrastructures, hampering and injuring our employees on the way or during their work. These events could disrupt supply chains, interrupt business operations, and damage the Group's assets. The Group has taken different actions to manage the abovementioned acute physical risks. For example, the Group has developed the practice of communicating the arrangements under extreme weather conditions to employees in advance. The potential financial impacts can be minimised with adequate preparations for extreme weather events.

Transition Risks

There are more stringent climate legislations and regulations to support global vision for decarbonisation. For example, the HKEX has required the listed companies to enhance the climate-related disclosures in their ESG reports. The Group's reputation may be damaged due to failure to comply with such regulations, which may also expose the Group to higher risks of claims and lawsuits. In response to the policy and legal risks as well as the reputation risks, the Group regularly monitors existing and emerging trends, policies and regulations relevant to climate change, and will alert the top management where necessary to avoid cost increments, non-compliance fines or reputational risks due to delayed response.

B. SOCIAL

B1. Employment

The Group recognises that employees are the most valuable asset of the Group and are the foundation of the Group's success. As such, the Group has continued with its good employment practices to ensure sustainable growth of the business. Relevant employment policies are formally documented in the Employee Handbook, covering recruitment and remuneration, compensations, working hours and rest periods, diversity and equal opportunities, etc. The Group periodically reviews these employment policies to ensure continuous improvement of its employment standards and competitiveness against companies of the similar industry.

During FY2022, the Group was not aware of any material non-compliance with employment-related laws and regulations that would have a significant impact on the Group, including but not limited to the Employment Ordinance of Hong Kong, the Labour Law of the People's Republic of China, the Social Insurance Law of the People's Republic of China, the Company Law of the People's Republic of China and the Labour Contract Law of the People's Republic of China.

Recruitment, Promotion and Remuneration

Employees are recruited via a robust, transparent and fair recruitment process based solely on their experience and suitability for the positions, regardless of their age, religion, ethnicity, origin, gender identity, physical disability and marital status, etc. Employees are assessed and chosen based on their ability and potential to fulfil the Group's current and future needs. The Group is adamant in treating and evaluating its employees in a fair and unprejudiced way.

Remuneration and promotion are based on job-related skills, qualifications and performances. The Group will conduct an annual performance and salary review to determine any salary adjustments and/or promotion opportunities. The Group also gives priority to internal promotion in order to provide incentive to employees for their consistent and continuous efforts.

Remuneration packages include variable bonuses, annual leave, maternity leave, etc. In accordance with the applicable laws of Mainland China, the Group legally pays "five social insurance and one housing fund" for its employees in Mainland China, namely endowment insurance, medical insurance, unemployment insurance, employment injury insurance, maternity insurance, and housing provident fund. For employees in Hong Kong, monthly contributions to the Mandatory Provident Fund Scheme are made pursuant to the Mandatory Provident Fund Ordinance of Hong Kong.

Working Hours and Rest Periods

To ensure a healthy work-life balance for employees, the Group has formulated policies in determining the working hours and rest periods for employees in accordance with local employment laws. Subject to company or departmental arrangement, employees are eligible for overtime payment.

Compensation and Dismissal

The Group offers fair compensation packages for employees based on employees' personal capability and benchmark. In addition, the Group complies with the Employees' Compensation Ordinance of Hong Kong and Labour Law of the People's Republic of China, which covers employees who sustain personal injury by accident or disease arising out of the course of employment. 薪酬待遇包括金額可變花紅、 年假、產假等。根據適用的 中國內地法律,本集團為其 中國內地僱員合法支付「五險 一金」,即養老保險、醫療保 險、失業保險、工傷保險、生 育保險,以及住房公積金。香 港僱員則根據香港強制性公積 金條例,每月向強制性公積金 計劃供款。

The Group prohibits any unreasonable dismissals under any circumstances and ensures that dismissal would be conducted based on reasonable and lawful grounds supported by internal policies. Verbal or written warnings will be issued before the official dismissal to provide the staff with an opportunity for improvement. If no improvement is noted, the Group shall then consider dismissal only upon receiving dismissal instruction from the relevant department.

Equal Opportunities, Diversity and Anti-discrimination

The Group values diversity in its talent pool and is dedicated to ensuring that equal opportunities are given to each employee. The Group is committed to creating and maintaining an inclusive and collaborative workplace culture. Furthermore, the Group is dedicated to protecting its employees from discrimination, physical or verbal harassment based on race, religion, colour, gender, physical or mental disability, age, place of origin, marital status, and sexual orientation. The Group does not tolerate sexual harassment or abuse in the workplace in any form. B2. Health and Safety

Provision of Safe Environment to Employees

The Group highly values employees' health and safety and is always committed to maintaining a safe and pleasant working environment for all its employees. The Group has also maintained strict compliance with local laws and regulations and has adopted occupational health and safety guidelines recommended by the Labour Department and Occupational Safety and Health Council and have developed relevant policies.

During FY2022, the Group was not aware of any material non-compliance with health and safety-related laws and regulations that would have a significant impact on the Group, including but not limited to the Occupational Safety and Health Ordinance of Hong Kong, the Labour Law of the People's Republic of China, the Production Safety Law of the People's Republic of China, the Prevention and Treatment of Occupational Diseases of the People's Republic of China and the Fire Protection Law of the People's Republic of China. There were no reported cases of work-related fatalities in each of the past three years including FY2022 and no lost days due to work injury during FY2022, hence no claims or compensation was paid to its employees due to such accident.

To ensure a hazard-free working environment, the Group stresses the importance of keeping the corridors clean, classifying and recycling waste where possible, cleaning air-conditioning equipment and carpet on a regular basis and participating in regular health and safety seminars. To minimise the risk of a fire hazard, fire extinguishers are strategically placed and fire exits are free from obstruction.

B2. 健康與安全

向僱員提供安全環境

於二零二二財年,本集團並不 知悉任何對本集團造成重大影 響的任何嚴重違反健康及安全 相關法律法規的行為,包括但 不限於香港《職業安全及健康 條例》、《中華人民共和國勞動 法》、《中華人民共和國安全生 產法》、《中華人民共和國職業 病防治法》及《中華人民共和 國消防法》。於過去三年各年 (包括二零二二財年),並無錄 得因工死亡個案,亦無於二零 二二財年錄得因工傷而損失的 工作日數,因此並無因該等事 故向其僱員支付任何索賠或賠 償。

為確保本集團工作環境不存在 危險,本集團強調保持走廊清 潔、盡量分類及回收廢物、定 期清潔空調設備及地毯並定期 參加健康與安全研討會的重要 性。滅火器要有策略地置放及 消防出口不得堵塞,而降低火 患風險。

Improving Safety Awareness

The Group complies with related working safety guidelines and constantly educates and reminds employees of the importance of work health and safety. The Group provides employees with relevant information on crime prevention and emergency response through training, promotions, drills and regular safety inspections. We also participate in regular fire drills to raise employees' safety and fire prevention awareness. If there are any violations of the guidelines, we will take appropriate disciplinary actions or legal proceedings against the staff to raise employees' health and safety awareness during work.

Prevention Control on COVID-19

In view of the COVID-19 outbreak, the Group has taken proactive measures to safeguard the health and safety of its employees and business partners and has complied with public health measures implemented by the local authorities. The Group has increased the frequency of sanitisation in the Group's premises and prepared surgical masks and hand sanitisers for the use of its employees. To further minimise the risk of cross-infection, all employees and clients of the Group are also required to perform temperature checks before entering the Group's premises.

General Disclosure

Training and Development

Training and continuous development are indispensable to the Group's employees to keep abreast of the rapidly changing trend in the industry. The Group has developed relevant policies on employees' knowledge and skills development.

Employees are encouraged to apply for internal and external training courses to refresh prior knowledge. The Group encourages employees to familiarise themselves with newly updated guidelines, maintain their competitiveness within the industry and ensure legal compliance in dealing with sensitive matters and data.

Internally, the Group holds work-related talks and seminars. Training contents are regularly updated to be in line with the industrial standard, the Group's business nature and to provide maximum benefit to the employees. B3. 發展及培訓

B4. Labour Standards

Prevention of Child and Forced Labour

Child and forced labour are strictly prohibited during the recruitment process as defined by laws and regulations. Personal data is collected during the process to assist the selection of suitable candidates and to verify candidates' personal data and that they have reached the minimum legal age to work in respective jurisdictions.

According to the Employee Handbook, the Human Resources Department also ensures identity documents are thoroughly checked. The Human Resources Department has established a reporting mechanism to ensure compliance with all relevant laws and regulations. If violation is involved, it will be dealt with in the light of the circumstances promptly. Upon discovery of child labour, the said person will be discharged immediately. To prevent the forced labour, the employment contract specifies the agreement between the Group and its employees on the working conditions including among others, their normal working hours and overtime work arrangement. Overtime working of employees is on a voluntary basis to avoid violating labour standards and to protect employees' rights and interests. If there is any suspected infringement regarding forced labour, the Group might conduct investigation and take disciplinary actions against any staff members who are responsible for the cause of the incident. The Group will regularly conducts reviews and inspections to ensure such measures and procedures are effective. Upon discovery of child and forced labour cases, the Group will discuss preventive measures to avoid a similar event from happening again.

B4. 勞工準則

防止童工及強制勞工

法律法規規定,招聘過程中嚴 禁童工及強制勞工。在此過程 中將收集個人資料,以幫助選 擇合適的候選人並驗證候選 人的個人資料及他們已達到在 各司法權區工作的最低法定年 齡。

根據僱員手冊,人力資源部還 確保對身份證明文件進行徹 查。人力資源部建立了報告機 制,以確保遵守所有相關法律 法規。倘涉及違規行為,將根 據情況立即予以處理。一旦發 現童工,將立即解聘該名人 士。為防止強制勞工,僱傭合 約訂明本集團與其僱員之間有 關工作條件的協議,包括(其 中包括)彼等的正常工作時間 及加班安排。員工加班遵循自 願原則,避免違反勞工準則, 並保障員工權益。倘有任何涉 嫌違反有關強制勞工的行為, 本集團可能會對負責事故原因 的任何員工進行調查並採取紀 律處分。本集團將定期進行檢 討及檢查,以確保有關措施及 程序行之有效。一旦發現童工 及強制勞工個案,本集團將討 論預防措施,以避免再次發生 類似事件。



During FY2022, the Group was not aware of any material non-compliance with child and forced labour-related laws and regulations that would have a significant impact on the Group, including but not limited to the Employment Ordinance of Hong Kong, the Labour Law of the People's Republic of China and the Labour Contract Law of the People's Republic of China.

B5. Supply Chain Management

Fair and Open Tendering

The engagement with service providers takes place under a fair and open tendering process, it takes suppliers' experience, reputation, prevailing market, price and reputation into account. The Group has established procedures for procurement and logistics management to ensure that the products procured are of satisfactory quality, thereby reducing procurement cost. The Group strives not to over-rely on a specific supplier in order to ensure stability of the supply chain. At the same time, the Group aims to strengthen collaborative relationships with existing suppliers. Should the performance of the supplier fall below contractual expectations, the contract may be terminated.

Employees are reminded to avoid situations that may lead to or involve potential conflict of interest. Any discrimination against certain vendors without reasonable grounds and any types of business bribery are strictly prohibited.

During the Reporting Period, the Group had engaged a total of 29 major suppliers (FY2021: 67 major suppliers), 20 suppliers are from Mainland China, while 9 suppliers are from Hong Kong, China, and all major suppliers are subject to the above evaluation and monitoring regularly. 於二零二二財年,本集團並不 知悉會對本集團造成重大影響 的任何嚴重違反童工及強制勞 工相關法律法規的行為,包括 但不限於香港《僱傭條例》、 《中華人民共和國勞動法》及 《中華人民共和國勞動合同 法》。

Environmentally and Socially Responsible Supply Chain

The Group has established relevant policy to manage the environmental and social impacts in our supply chain. In accordance with this policy, we assess suppliers' environmental and social performance in our procurement and tendering process to ensure that our suppliers are aware of and have established minimum standards for the environmental, social and ethical issues relevant to their operations.

With an objective to minimise the carbon emission and to support local economy and community, we mainly sourced our materials, products and services locally in Hong Kong. In addition, the Group has ensured that the purchased office equipment has Energy Efficiency Label and purchased stationery uses environmental-friendly packaging with certifying scheme.

The Group will also regularly review the effectiveness of its supply chain management measures.

B6. Product Responsibility

Solid corporate governance and risk management are essential to the Group's long-term development and sustainable growth. The Group periodically revises existing corporate rules and regulations and ensures strict compliance with local laws and regulations.

During FY2022, the Group was not aware of any material non-compliance with laws and regulations that would have a significant impact on the Group, concerning advertising, labelling and privacy matters relating to products and services provided, including but not limited to, the Money Lenders Ordinance, the Personal Data (Privacy) Ordinance, the Securities and Futures Ordinance of Hong Kong and the Protection of Consumer Rights of the People's Republic of China. During FY2022, the Group did not receive any major product or service-related complaints. Due to the Group's business nature, product recall is not applicable to the Group.

Moreover, the Group has set standards for advertising and sales material. Information disclosed in all advertising and sales materials must be factual; we also prohibit the use of false, misleading or inaccurate statements in any forms of communication.

Money-lending Assurance

As a licenced money lender in Hong Kong, the Group holds an active Money Lenders Licence. In addition, the Group abides by the Money Licensing Conditions of the said licence. As a result of a more stringent additional licensing conditions on money lender licences, a risk-warning message must be present in all advertisements in relation to money lending business. The guideline stipulates that advertisement, whether in textual, audio or visual form, must contain the relevant subsidiary's telephone hotline for handling complaints and a well-established risk warning statement. The said risk warning statement must also be clearly audible in the audio part of the advertisement.

放債保證

作為香港持牌放債人,本集團 持有有效的放債人牌照。此 外,本集團遵守上述牌照的發 牌條件。由於放債人牌照的附 加發牌條件更為嚴格,因此所 有放貸業務相關的廣告均須有 風險警告信息。該指引規定, 廣告(無論是以文字、音頻或 視覺形式)均須包含相關附屬 公司的電話熱線以處理投訴及 完善的風險警告聲明。所述風 險警告聲明還須在廣告的音頻 部分中清晰可聞。



Customer Privacy Protection

The Group protects legitimate rights and interests of its customers, respects the rights of customers' information assets and strictly complies with the customers' information security management systems and standards. The Group has formulated a set of privacy guidelines in regard to the collection, retention and accessibility of information to ensure that the lessee's sensitive information is only used for its intended purposes and to prevent information leakage. All employees are trained to respect the confidentiality of customers' information, while only certain employees can access sensitive customer data. Moreover, employees are required to sign a confidentiality agreement to hold them accountable for should there be any unlawful information leakage. The Group will review the policies regularly to ensure its effectiveness.

Intellectual Property Rights

Despite intellectual property rights are not considered a material ESG aspect to the Group due to the Group's business nature, the IT Department is in charge of securing proper licenses for software, hardware and information that the Group uses in its business operation. Duplication or downloading of information, software, and images from the internet must be approved by relevant department. Furthermore, the Group closely monitors and prevents any infringement behaviour such as counterfeit trademarks in the market. The Group will continue to monitor to ensure that its intellectual property rights are not being infringed upon.

Customer Service Quality

The Group strives to provide excellent services in response to customers' enquiries. A customer services team has been established, and standard procedures have been established to handle customers' opinions and comments. To further enhance and better the Group's services, customers are encouraged to provide feedback on their experience. Feedbacks are recorded in detail and appropriate follow-up actions will be taken should it be deemed necessary.

Procurement Quality Control

The Group has a dedicated quality control team to ensure the products procured are of satisfactory quality and would not pose any significant health threat to its consumers. Standard procedures are established to govern the procurement, quality assurance and storage of these products. Due to the Group's business nature, the Group has an insignificant amount of business dealing regarding labelling matters.

B7. Anti-corruption

The Group values and upholds integrity, honesty, and fairness in how the Group conducts business. The Group emphatically asserts its zero-tolerance stance regarding any behaviours that violate local laws and regulations and severely damage the Group's reputation.

During FY2022, the Group was not aware of any material non-compliance with laws and regulations of bribery, extortion, fraud, and money laundering that would have a significant impact on the Group, including but not limited to the Anti-Money Laundering and Counter-Terrorist Financing (Financial Institutions) Ordinance, the Money Lenders Ordinance, the Personal Data (Privacy) Ordinance, Securities and Futures Ordinance in Hong Kong, the Anti-Unfair Competition Law of the People's Republic of China and the Criminal Law of the People's Republic of China. Also, there were no concluded legal cases regarding corrupt practices brought against the Group's issuer nor its employees during FY2022 (FY2021: 0 case).

Anti-money laundering and Counter-financing of Terrorism

As a professional financial services provider, the Group is particularly sensitive to the signs of money laundering and financial crimes. Apart from complying with local laws and guidelines established by regulatory authorities, the Group recognises that the responsibility to help protect the integrity of the financial system lies within us. The Anti-Money Laundering and Counter-Terrorist Financing Policy is in place to safeguard the interests of the Group. It states the roles and responsibilities of compliance officers and details procedures such as conducting customer due diligence check before starting business dealings with them and reporting suspicious transactions. The Group also provide training on anti-money laundering to Directors and employees at least annually to maintain their anti-corruption awareness and good professional conduct and to comply with the regulations in Hong Kong and the China. During the Reporting Period, the Group has provided reading materials related to anti-corruption for Directors and employees for their self-study.

作為專業的金融服務供應商, 本集團對洗錢及金融犯罪的跡 象尤為敏感。除遵守監管機構 制定的當地法律及指引外,本 集團還認為幫助保護金融體系 完整性的責任有賴我們。為維 護本集團利益制定了《反洗錢 及反恐怖分子融資政策》。該 政策列明合規負責人的角色與 職責,並詳細説明了程序,例 如在開始與客戶進行業務往來 前開展客戶盡職調查並報告可 疑交易之程序。本集團亦最少 每年為董事及僱員提供反洗錢 培訓,以維持他們的反貪污意 識及良好的專業操守,並遵守 香港及中國的法規。於報告期 間,本集團已為董事及僱員提 供有關反貪污的閱讀材料,以 供彼等自行學習。



Prevention of Money Laundering, Fraud and Bribery Practices

The Group is sensitive to money laundering, potential fraud, and bribery practices. Therefore, the Group provides guidelines to employees to remind them of good practices to prevent unnecessary legal complications.

Whistle-blowing Mechanism

The Group has established relevant policy to provide communication channels for employees to report concerns on the occurrence (either actual or suspicious) of any incidents regarding corruption or criminal activity, non-compliance with legal and regulatory requirements, miscarriages of justice, actions which endanger the health and safety of any individuals, and existing and possible improprieties relating to financial reporting, internal control, and other matters. The identity of the whistle-blower will be kept confidential. The Group will review the policy regularly to ensure its effectiveness.

B8. Community Investment

Community Participation

The Group is committed to providing career opportunities to local residents and considers the development of the community's economy as part of the Group's sustainable development strategy. To this end, the Group has established relevant guidelines and policies to encourage its employees to give back to the society which do not only benefit the society but also nurture a good corporate culture.

Due to the COVID-19, the Group did not arrange community activities during the Reporting Period, echoing to government social distancing measures. The Group will continue to look into engaging in more community events like environmental and labour needs, etc. in the coming years.

In 1996, he co-founded WebEx Communications Inc. which was successfully listed on NASDAQ in 2000 and then acquired by Cisco Systems Inc. for US\$3.2 billion in 2007.

In 2003, Mr. Zhu became the sole investment partner in China of New Enterprise Associates (NEA), a renowned U.S. based venture capital fund focusing on early- and middle-stage companies, assisting NEA to successfully invest in a group of independent innovation enterprises in China. In 2005, Mr. Zhu founded Cybernaut Investment Group, one of China's best venture capital houses in 2015 selected by Forbes. It is one of the leading private equity and venture capital fund in China.

Mr. Zhu has many years of experience in computer, network communications and services. He is a well-known scientist in the field in the United States. In 2002, he was named by Business Week as one of the 25 most influential people in global e-commerce. In 2008 and 2009, Mr. Zhu was selected by Forbes as one of China's best venture capital investors. At the first China Public Entrepreneurship and Innovation Conference held in 2016, he was granted the title of China's Pioneer in Innovation and Entrepreneurship by virtue of his reputation in the international investment community.

Mr. Zhu is the founder and chairman of the board of Cybernaut Investment Group Limited, the Vice president of China Society for the Promotion of Science and Technology Commercialization, the founder and dean of the Zhejiang University International Innovation Institute (ZII).

Mr. Zhu is currently the directors of its subsidiaries, namely 湖 州賽樂弘教育科技有限公司 Huzhou Sai Le Hong Education Technology Limited ("湖州公司", "Huzhou Company"), Cybernaut Asia Pacific Limited, Hong Kong Cybernaut Technology Limited and Cybernaut Technology International Limited.

The maximum number of Shares issuable upon exercise of the options which may be granted under the Share Option Scheme and any other share option scheme of the Group (including both exercised and outstanding options) to each participant in any 12-month period shall not exceed 1% of the issued share capital of the Company for the time being. Any further grant of share options in excess of this limit is subject to Shareholders' approval in a general meeting.

In addition, where any grant of share options to a substantial shareholder or an independent non-executive Director, or to any of their respective associates, would result in the Shares issued and to be issued upon exercise of all options already granted and to be granted (including options exercised, cancelled and outstanding) to such person in excess of 0.1% of the Shares in issue and with an aggregate value (based on the closing price of the Shares at the date of the grant) in excess of HK\$5 million, in a 12-month period up to and including the date of grant, such grant of share options are subject to Shareholders' approval in a general meeting.

The offer of a grant of share options may be accepted within 21 days from the date of the offer, upon payment of a nominal consideration of HK\$1 by the grantee. The exercise period for the share options granted is determined by the Board, whose period may commence from the date of acceptance of the offer for the grant of share options but shall end in any event not later than 10 years from the date of the grant of the option subject to the provisions for early termination under the Share Option Scheme.

The subscription price for Shares under the Share Option Scheme shall be a price determined by the Board, but shall not be less than the highest of:

- the closing price of Shares as stated in the daily quotations sheet of the Stock Exchange on the date of the offer of the grant, which must be a trading day;
- the average closing price of the Shares as stated in the Stock Exchange's daily quotations sheets for the five trading days immediately preceding the date of the offer of grant; and
- (iii) the nominal value of a Share.

The Company's share option scheme (the "New Scheme") was adopted pursuant to a resolution passed on 24 September 2021. Under the New Scheme, the Board of Directors of the Company may grant option to eligible employees, including directors of the Company and its subsidiaries, to subscribe for shares in the Company.

At 31 December 2022, the number of shares in respect of which options had been granted and remained outstanding under the New Scheme was 120,000,000, representing 3.02% of the shares of the Company in issue at that date. The total number of shares in respect of which options may be granted under the New Scheme is not permitted to exceed 10% of the shares of the Company in issue at any point in time, without prior approval from the Company's shareholders. The number of shares issued and to be issued in respect of which options granted and may be granted to any individual in any one year is not permitted to exceed 1% of the shares of the Company in issue at any point in time, without prior approval from the company is shareholders.

At 31 December 2022, the maximum number of Shares which may fall to be issued upon exercise of the Options to be granted under the New Scheme will be 397,544,800 Shares, representing approximately 10% of the total number of Shares in issue, which will not exceed the 30% limit under Note 2 to Rule 17.03(3) of the Listing Rules.

As at 31 December 2022, the Group had carrying amount of goodwill of approximately RMB72,938,000, which were allocated to the cashgenerating unit of Money lending business (the "CGU"). For the purpose of assessing impairment, the Group appointed an independent external valuer to assess the recoverable amount of the CGU, which were determined by management based on the higher of value in use and fair value less costs of disposal. The valuation requires significant judgement made by management in determining the CGU.

As at 31 December 2022, the Group had loan receivables of approximately RMB176,460,000. During the year ended 31 December 2022, there is impairment loss recognised of loan receivables RMB2,303,000.

- (c) In accordance with the relevant laws and regulations of the People's Republic of China ("PRC"), the PRC subsidiaries are required to provide for PRC statutory reserves, including enterprise expansion fund and general reserve fund, by way of appropriations from its statutory net profit (based on the PRC statutory financial statements of the PRC subsidiaries) but before dividend distributions.

All appropriations to the funds are made at the discretion of the board of directors of PRC subsidiaries. The board of directors of the PRC subsidiaries shall decide on the amounts to be appropriated based on its profitability each year.

The enterprise expansion fund may be used to increase registered capital subject to approval from the relevant PRC authorities. The general reserves fund may be used to offset accumulated losses or increase the registered capital subject to approval from the relevant PRC authorities.

- (d) Share options reserve comprises the fair value of share options granted which are yet to be exercised. The amount will be transferred to accumulated losses when the related options are exercised, expired or forfeited.
- (e) Exchange reserve comprises all foreign currency differences arising from the translation of the financial statements of subsidiaries whose functional currencies are currency other than RMB.

Basis of preparation of consolidated financial statements

The consolidated financial statements have been prepared in accordance with HKFRSs issued by the HKICPA. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on the Stock Exchange ("Listing Rules") and by the Hong Kong Companies Ordinance.

The consolidated financial statements have been prepared on the historical cost basis except for certain financial instruments that are measured at fair values at the end of each reporting period, as explained on the accounting policy set out below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKFRS 2 Sharebased Payment, leasing transactions that are accounted for in accordance with HKFRS 16, and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 Inventories or value in use in HKAS 36 Impairment of Assets.

For financial instruments which are transacted at fair value and a valuation technique that unobservable inputs is to be used to measure fair value in subsequent periods, the valuation technique is calibrated so that at initial recognition the results of the valuation technique equals the transaction price.

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each item of other comprehensive income are attributed to owners of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

All intragroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

Non-controlling interests in subsidiaries are presented separately from the Group's equity therein, which represent present ownership interests entitling their holders to a proportionate share of net assets of the relevant subsidiaries upon liquidation.

Goodwill

Goodwill arising on an acquisition of a business is carried at cost as established at the date of acquisition of the business less accumulated impairment losses, if any.

For the purposes of impairment testing, goodwill is allocated to each of the Group's cash-generating units (or groups of cash-generating units) that is expected to benefit from the synergies of the combination, which represents the lowest level at which the goodwill is monitored for internal management purposes and not larger than an operating segment.

Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recognised at the rates of exchanges prevailing on the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Nonmonetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences on monetary items are recognised in profit or loss in the period in which they arise.

Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of exchange reserve.

On the disposal of a foreign operation, (i.e. a disposal of the Group's entire interest in a foreign operation, a disposal involving loss of control over a subsidiary that includes a foreign operation), all of the exchange differences accumulated in equity in respect of that operation attributable to the owners of the Company are reclassified to profit or loss.

Government grants related to income that are receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable. Such grants are presented under "other gain or loss, net".

When a lease includes both land and building elements, the Group assesses the classification of each element as a finance or an operating lease separately based on the assessment as to whether substantially all the risks and rewards incidental to ownership of each element have been transferred to the Group, unless it is clear that both elements are operating leases in which case the entire lease is classified as an operating lease. Specifically, the minimum lease payments (including any lump-sum upfront payments) are allocated between the land and the building elements in proportion to the relative fair values of the leasehold interests in the land element and building element of the lease at the inception of the lease.

Retirement benefits costs

The Group contributes to a defined contribution Mandatory Provident Fund retirement benefits scheme (the "MPF Scheme") under the Mandatory Provident Fund Scheme Ordinance for all employees in Hong Kong. Contributions are made based on a percentage of the employees' relevant income and are charged to profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed in the MPF Scheme. Under the MPF Scheme, the employer and its employees are each required to make contribution to the MPF Scheme at 5% of the employees' relevant income subject to a cap of monthly relevant income of HK\$30,000. Contributions to the MPF Scheme vest immediately.

These subsidiaries are required to contribute a certain percentage of its payroll costs to the central pension scheme. The contributions are charged to profit or loss as they become payable in accordance with the rules of the central pension scheme. The Group's employer contributions vest fully with the employees when contributed in the central pension scheme. The Group has no forfeiture of pension scheme contributions (i.e. contributions processed by the employer on behalf of the employee who has exited the scheme prior to vesting of such contributions). As at 31 December 2022, no forfeited contribution under the pension scheme of the Group is available for deduction of contribution payable in coming vears.

Short-term and other long-term employee benefits

Short-term employee benefits are recognised at the undiscounted amount of the benefits expected to be paid as and when employees rendered the services. All short-term employee benefits are recognised as an expense unless another HKFRS requires or permits the inclusion of the benefit in the cost of an asset.

A liability is recognised for benefits accruing to employees (such as wages and salaries, annual leave and sick leave) after deducting any amount already paid.

Deferred tax liabilities are generally recognised for all taxable temporary differences. 

The provision of ECL is sensitive to changes in estimates. The information about the ECL and the Group's trade receivables and loan receivables are disclosed in note 25 and note 26.

The Group assesses each cash-generating unit annually to determine whether any indication of impairment exists. When an indicator of impairment exists, a formal estimate of the recoverable amount is made, which is considered to be the higher of the fair value less costs of disposal and value in use. The carrying amount of the property, plant and equipment and intangible assets are reviewed for impairment when events or changes in circumstances indicate that the carrying amount may not be recoverable in accordance with the accounting policy as disclosed in the relevant part of this section. Estimating the value in use requires the Group to estimate future cash flows from the cash generating units and to choose a suitable discount rate in order to calculate the present value of those cash flows.

Impairment of goodwill

Determining whether goodwill is impaired requires an estimation of the recoverable amount of the cashgenerating unit (or group of cash-generating units) to which goodwill has been allocated, which is the higher of the value in use or fair value less costs of disposal. The value in use calculation requires the Group to estimate the future cash flows expected to arise from the cashgenerating unit (or a group of cash-generating units) and a suitable discount rate in order to calculate the present value. Where the future cash flows are less than expected, or change in facts and circumstances which results in downward revision of future cash flows or upward revision of discount rate, a material impairment loss or further impairment loss may arise.

5. CAPITAL RISK MANAGEMENT

The Group manages its capital to ensure that the entities in the Group will be able to continue as a going concern while maximising the return to shareholders through the optimisation of the debt and equity balance. The Group's overall strategy remains unchanged from prior year.

The capital structure of the Group consists of cash and cash equivalents and equity attributable to owners of the Company, comprising share capital, reserves and retained profits.

The management reviews the capital structure on a semiannual basis. As part of this review, the management considers the cost of capital and the risks associated with each class of capital. Based on recommendations of the management, the Group will balance its overall capital structure through the payment of dividends, new share issues and share buybacks as well as the issue of new debt or the redemption of existing debt.





Cash flows beyond the 5-year period (2021: 5-year period) are extrapolated with 2.5% (2021: 2%) growth rate. On 24 July 2021, Opinions were issued in July by the General Office of the Central Committee of the Communist Party of China and the General Office of the State Council of the PRC, on Further Reducing the Burden of Compulsory Education Students' Homework and Off-campus Training (關於進一步減輕義務教育階段學生作業負擔和校外培訓負擔的意見) (the "Opinions"), which regulates institutions offering tutoring on the school curriculum; and the Beijing Municipality's Measures to Further Reduce the Burden of Homework and After – School Tutoring on Students in Compulsory Education in Beijing issued in August 2021 by the Beijing Municipality Government and the Beijing Municipal Committee of the Communist Party of China (together with the Opinions, as the "New Regulations").

In light of the New Regulations and with a view to ensure that the Group and its operations fully in compliance with all applicable legal and regulatory requirements in China; and after seeking legal advice in early December 2021, the Company's board (the "Board") of directors (the "Directors") has decided that the Group to cease the online after-school tutoring services for academic subjects included in China's compulsory education system offered to Kindergarten to Year Nine ("K-9" or "Compulsory Education") students in PRC. As such, the relevant intangible assets and goodwill was fully impaired during the year ended 31 December 2021.

Since the new education regulations incorporating the Opinions (issued in August 2021 by the Beijing Municipality Government) governing the after school tutoring educational activities might have lasting impacts and detrimental effects on the future operation of the Company's subsidiary group of online education under the VIE structure, and with reference to the voluntary announcement of the Company dated 28 December 2021 in relation to update on business operations, the Company decided to undergo organizational restructuring of the education business segment by having Wowxue become a wholly-owned subsidiary of the Company, so that we can continue to provide different kind of educational services and to develop new market in the PRC education industry. In early 2022, Wowxue has surrendered the ICP licenses to the China government for its cancellation in compliance with the new education regulations. After surrendered the ICP licenses, Wowxue's shareholders and directors have signed a legally-bound undertaking which they all irrevocably undertake to the Company that they will assist the organizational restructuring till completion after the VIE terminated.

Irrecoverable option agreement

Huzhou Company, Wowxue and the Registered Shareholders entered into an irrevocable exclusive option agreement (the "Option Agreement") whereby the Registered Shareholders granted an exclusive option to Huzhou Company to acquire the entire equity interest in Wowxue held by the Registered Shareholders, under which Huzhou Company shall have the right to require the Registered Shareholders to transfer their equity interest in Wowxue on demand to Huzhou Company or its designated entity or individual, at nil consideration. The Option Agreement does not have a defined exercisable period and the Option Agreement will expire when the relevant law and regulation in the PRC allows foreign investment in Wowxue or when Huzhou Company or its designated party exercises the option to acquire Wowxue.



Service Agreement

Huzhou Company and Wowxue entered into an exclusive service agreement (the "Service Agreement") pursuant to which Huzhou Company shall serve as the service provider to Wowxue, to provide investment advice, planning and other business advice on the operation and technical services of Wowxue in accordance with the requirements of Wowxue.

In consideration of the provision of the abovementioned services by Huzhou Company, Wowxue agrees to pay to Huzhou Company fees on an annual basis. Fees payable to Huzhou Company by Wowxue will be equivalent to the total income of Wowxue minus all relevant costs, expenses and taxes payable by Wowxue. If there is a loss in a given year, then no provisions for the said management and consultancy fees would be required for the year until Wowxue records a surplus.

In addition, Huzhou Company shall have the right to obtain and review the business data, financial information and other information relevant to the operations and business of Wowxue.

The Service Agreement has a term of ten years from the date of signing the Service Agreement. Upon the expiry of each term, Huzhou Company is entitled at its sole and absolute discretion to renew the Service Agreement for a further term of ten years for each renewal.

Huzhou Company, Wowxue and the Registered Shareholders entered into an equity pledge agreement (the "Equity Pledge Agreement") pursuant to which the Registered Shareholders unconditionally and irrevocably agreed to pledge all the equity interest in Wowxue that they own (including any interest or dividend paid for such shares) to Huzhou Company as a security for the performance of the obligations by Wowxue and the Registered Shareholders under the Service Agreement.

The Equity Pledge Agreement became effective from the date when the agreement was entered into and shall remain valid until Wowxue and the Registered Shareholders unconditionally and irrevocably fulfilled all the obligations (including, but not limited to, the settlement and/or the payment of the service charge, liquidated damages (if any), etc.) under the Service Agreement.

Power of attorney

The Registered Shareholders executed an irrevocable power of attorney which enables Huzhou Company to exercise all the powers of the shareholders of Wowxue.

Pursuant to the Power of Attorney, the directors of Wowxue, the Registered Shareholders and the legal representative of Wowxue have irrevocably appointed Huzhou Company as its/their attorney-in-fact to (i) exercise all the directors' rights, shareholders' rights and legal representative's rights (as the case may be) including but not limited to passing of board resolutions and shareholders' resolutions as well as the right to appoint or remove the directors, legal representative, general manager and other senior management of Wowxue; (ii) sign on their behalf all the documents necessary to give effect to the Contractual Arrangements; (iii) exercise all the rights and powers under the Equity Pledge Agreement and the right to deal with the assets of Wowxue; and (iv) submit documents to the competent company registration authorities of Wowxue or other relevant authorities for filing purpose.

The terms of the Power of Attorney became effective from the date of the Power of Attorney to the earlier of the revocation or termination of each of the Service Agreement, Irrevocable Option Agreement, Loan Agreement and Equity Pledge Agreement.

The directors of the Company, after consulting legal opinion, are of the view that the terms of the Contractual Arrangements have in substance enabled Huzhou Company to have power over Wowxue, rights to variable returns from its involvement with Wowxue, and has the ability to use its power to affect its returns, despite the absence of formal legal equity interest held by the Group in Wowxue. 
