CHANGE OF COMPANY NAME, STOCK SHORT NAME, COMPANY LOGO AND COMPANY WEBSITE

References are made to the announcement of Ciprun Technology Holdings Company Limited (formerly known as “**Cybernaut International Holdings Company Limited**”) (the “**Company**”) dated 31 October 2025, the notice of the Extraordinary General Meeting (the “**EGM**”) and the circular (the “**Circular**”) of the Company to the Shareholders both dated 25 November 2025 and the poll results announcement of the EGM dated 11 December 2025 in relation to, among others, the Proposed Change of Company Name.

Unless the context otherwise requires, capitalised terms used in this announcement shall have the same meanings as those defined in the Circular.

CHANGE OF COMPANY NAME

The Board is pleased to announce that following the passing of a special resolution approving the Proposed Change of Company Name by the Shareholders at the EGM held on 11 December 2025, the Certificate of incorporation on Change of Name was issued by the Registrar of Companies in the Cayman Islands certifying that the English name of the Company has been changed from “Cybernaut International Holdings Company Limited” to “Ciprun Technology Holdings Company Limited”, and the Chinese name “中細軟科技控股有限公司” has been adopted as the secondary name in Chinese to replace the former Chinese name “賽伯樂國際控股有限公司” (the “**Change of Company Name**”), both with effect from 16 December 2025.

The Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 16 January 2026 confirming the registration of the Company’s new English and Chinese names in Hong Kong under Part 16 of the Companies Ordinance (Cap. 622 of the Laws of Hong Kong).

CHANGE OF STOCK SHORT NAME

Following the Change of Company Name becoming effective, the stock short name of the Company for trading in the Shares on the Hong Kong Stock Exchange will be changed from “CYBERNAUT INT’L” to “CIPRUN TECH” in English and from “賽伯樂國際控股” to “中細軟科技” in Chinese with effect from 9:00 a.m. on 23 January 2026. The stock code of the Company on the Hong Kong Stock Exchange remains unchanged as “01020”.

CHANGE OF COMPANY WEBSITE

The Board further announces that the Company's website will be changed from "www.cybernaut.com.hk" to "www.cipruntech.com" with effect from the date of this announcement.

CHANGE OF COMPANY LOGO

The following logo will be adopted as the logo of the Company to reflect the Change of Company Name with effect from the date of this announcement:



EFFECT OF THE CHANGE OF COMPANY NAME AND THE CHANGE OF COMPANY LOGOS

The Change of Company Name and the change of the company logos will not affect any rights of the Shareholders or the Group's daily business operation and its financial position.

All existing certificates of securities in issue bearing the former name of the Company and the former company logo will continue to be evidence of legal title to such securities and the existing share certificates will continue to be valid for trading, settlement, registration and delivery purposes. There will not be any arrangement for exchange of the existing share certificates for new share certificates bearing the new name and the new logo of the Company. Going forward, new share certificates of the Company bearing the logo as shown on the top of this announcement will be issued in the new name of the Company and the Shares will be traded on the Stock Exchange under the new name of the Company.
