PROFIT WARNING

This announcement is made by Ciprun Technology Holdings Company Limited (the “**Company**”, together with its subsidiaries collectively referred to as the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571, Laws of Hong Kong) (the “**SFO**”).

The board of directors (the “**Board**”) of the Company hereby informs the shareholders (the “**Shareholders**”) and potential investors of the Company that, based on a preliminary review of the unaudited consolidated management accounts of the Group for the year ended 31 December 2025 and the financial information currently available, it is expected that the Group will record a loss for the year in the range of approximately RMB95 million to RMB100 million for the year ended 31 December 2025, as compared to a loss for the year of approximately RMB45 million for the year ended 31 December 2024. Such increase in the expected loss for the year ended 31 December 2025 was mainly due to the recognition of an impairment loss on the goodwill of the Group’s intellectual property related services cash-generating unit of approximately RMB42 million and money lending cash-generating unit of approximately RMB15 million.

The Company is in the process of finalising the annual results of the Group for the year ended 31 December 2025. The information contained in this announcement is only based on the preliminary review of the information currently available, and has not been reviewed by the audit committee of the Board or audited or reviewed by the independent auditors of the Company. The above information may be subject to further adjustments upon further review. Shareholders and potential investors are advised to read carefully the annual results announcement of the Group for the year ended 31 December 2025, which is expected to be published on 31 March 2026.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the securities of the Company.
